AN INTRODUCTION TO SUBMERGED AQUATIC VEGETATION (SAV)

Introduction

Submerged aquatic vegetation refers to flowering, vascular plant species that grow in salt, brackish, and fresh waters around the world. Some SAV species resemble grasses that grow on land; hence saltwater species are frequently referred to as seagrasses. Species inhabiting the Chesapeake Bay are collectively referred to as “Bay grasses”. Like terrestrial grasses, SAV species have leaves, seeds, roots, and stems. They can survive in diverse climates, including fresh tidal waters, under Arctic sea ice, off the shores of tropical islands, and in brackish estuaries like the Chesapeake Bay.

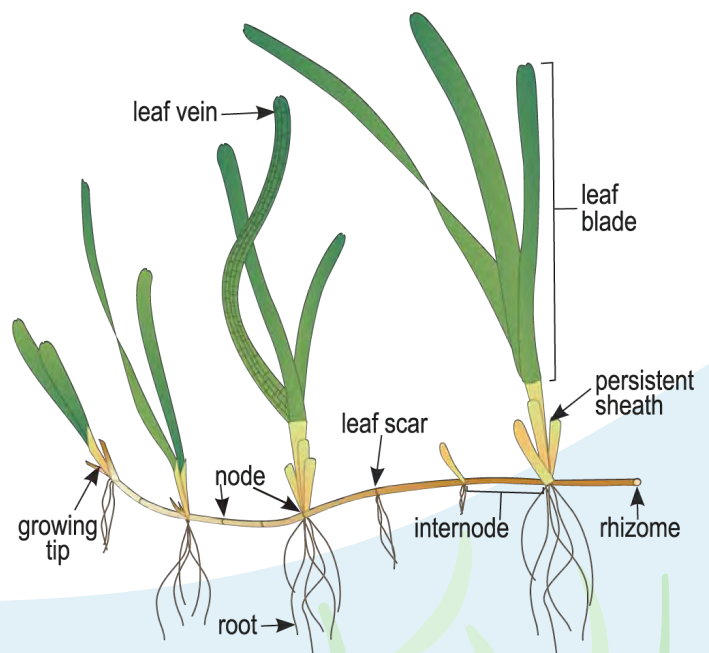

Biology

Anatomy

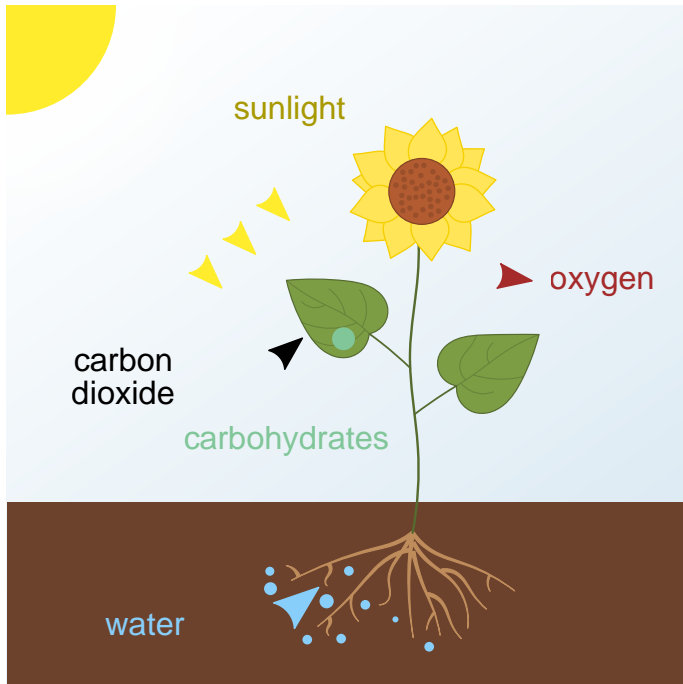
SAV species, like many of their terrestrial relatives, have roots and rhizomes (horizontally-growing underground stems that connect one clone to another) that anchor them in substrate and absorb nutrients. Veins and vessels, part of the plant vascular system similar to that of animals, spread from the roots and transport nutrients throughout the rest of the plant. As in other flowering plants, SAV species have stems to which leaves are attached. These leaves contain pigment cells (most often chlorophyll) that absorb sunlight. Seeds and flowers that grow on stalks make up the reproductive system of SAV, although many also reproduce asexually. In some species, the flower stalks grow above the water.

Photosynthesis

Like terrestrial plants, SAV species need sunlight for photosynthesis. Photosynthesis is the process by which specialized pigment cells (chloroplasts) in plants absorb certain wavelengths of sunlight. They combine this absorbed light energy with carbon dioxide and water to produce the energy they need to grow and live. Oxygen is a byproduct of photosynthesis.

Vascular System

The vascular system is made up of veins and vessels that circulate both the nutrients absorbed by the roots and the sugars produced by photosynthesis throughout the plant.

Reproduction

SAV reproduce both sexually and asexually. Both types of reproduction have advantages and disadvantages. Likewise, some species are monoecious (individual plants have both male and female flowers) and some are dioecious (plants are either male or female).

In sexual reproduction, male flowers release pollen that is distributed by currents. When

pollen reaches female flowers, fertilization occurs and a seed forms. Mature seeds are released and dispersed again by currents. In some species, seeds are attached to shoots that break off of the plant, and the seeds are released from the shoot once they are mature. Seeds eventually settle into the substrate and germinate into new plants. Seeds can be dormant for months or even years before germinating. This allows shoots to emerge when growing conditions are favorable.

Asexual reproduction in SAV occurs in a variety of ways, and some plants that reproduce sexually can also reproduce asexually. The most common form of asexual reproduction in SAV is called vegetative expansion. In vegetative expansion, rhizomes grow horizontally under the substrate and produce shoots that grow into new plants. Asexual reproduction can also occur when buds grow on the stems of already established, mature plants. These buds break off of the mature plant and sink into the substrate to grow. Some species also reproduce asexually through fragmentation. This usually occurs when a plant is physically disturbed and fragments of the parent plant float away with the current. Those fragments eventually settle and grow into new plants.

How does SAV differ from algae?

Although SAV and algae have their similarities, they evolved separately from one another. SAV evolved from terrestrial flowering plants and returned to the water, whereas algae never left the water in the first place. Algae and SAV are similar in that they both photosynthesize, but algae do not have roots or a vascular system like SAV species. Some species of algae do have a holdfast that anchors them to rocks or other surfaces, but it does not absorb nutrients like the roots of SAV do. Instead, algae have unspecialized cells that absorb nutrients directly from the water column.

How does SAV compare to terrestrial plants?

Although SAV species are flowering plants, they lack some common characteristics of terrestrial flowering plants. For example, most terrestrial flowering plants have pores, called stomata, that open and close to regulate water loss and nutrient exchange with the environment. SAV species do not have these structures; instead, they have a thin cuticle layer on their leaves that controls the exchange of oxygen, carbon dioxide, and nutrients with the surrounding water. Unlike terrestrial plants, SAV do not need strong stems or trunks to support them against gravity. Their weaker stems and leaves are supported by the surrounding water, and small air pockets within their tissues, called lacunae, help keep SAV buoyant.

Distribution & habitat requirements

SAV species are found in salt, brackish, and freshwater habitat on or around all continents except Antarctica. SAV species are sensitive to light availability, temperature, salinity, water currents, water quality, and substrate type. Overall water quality is extremely important. Because SAV species are rooted and cannot escape unfavorable conditions, they are susceptible to changes in water quality. Furthermore, different species have different environmental requirements, therefore habitat and environmental conditions strongly influence species distribution.

Light

Like terrestrial plants, SAV species require sunlight in order to photosynthesize. Because of this, they typically inhabit shallow, clear waters. Most species live in waters shallower than three meters, but some low-light adapted species can survive at depths of up to 58 meters. Many factors influence water clarity and therefore SAV distribution; these factors include depth, the amount of nutrients and sediments in the water, and the density of algal growth. Chesapeake Bay species are generally limited to waters no deeper than two meters because of turbidity; however, they could grow at greater depths with improved water clarity.

Salinity

SAV occupies fresh, brackish, and salt waters, but each species of SAV has a particular range of salinities that it can tolerate. The role of salinity in SAV species distribution is nicely illustrated in the Chesapeake Bay (see “Bay salinity regimes and effects on SAV distribution patterns” section for more details). In addition to driving species distribution, salinity may also affect SAV health. Changes in salinity caused by increased rainfall (which lowers salinity) or drought (which increases salinity) can lead to die-offs of particular species.

Temperature

Temperature can play an important role in SAV survival and reproductive capability. Some species require warm waters in order for seeds to germinate and develop into mature plants. Temperature requirements differ between SAV species. Coupled with seasonal changes, long-term temperature changes impact the ability of SAV to survive and persist in areas where they have historically thrived. One example of a temperature-dependent SAV species in the Bay is eelgrass. Eelgrass is a cold-water species with a historical range that includes the lower Bay; however, when the waters of the lower Bay where it lives get too warm, the eelgrass dies back.

Substrate and wave action

Substrate type influences SAV growth and distribution. Some species need sandy substrate, while others prefer muddy or silty areas. Most SAV do not tolerate strong waves or currents, and instead grow in calmer areas. Saltwater species typically inhabit gently sloping coastlines in areas of low wave activity.

Biodiversity

SAV are incredibly diverse with over 500 species worldwide. This number includes fresh, brackish, and saltwater species. Among these, 72 are considered true seagrass species that inhabit brackish and saltwater. There are over 20 species of SAV in the Chesapeake Bay, but only one of them, eelgrass, is a true seagrass. Widgeongrass inhabits many of the same areas and salinities as eelgrass, but it also thrives in less salty waters where it competes with other species, such as redhead grass and sago pondweed, for space. Species diversity increases in the freshwater areas of the Bay where over 17 species are commonly observed. Although many SAV species resemble land grasses, some look markedly different. Some species have round or oval-shaped leaves, others have cylindrical leaves, while still others resemble ferns. SAV species vary in height from less than three centimeters to just over 10 meters, though none grow that high in the Bay. SAV can grow in bushy clumps of a few plants, but many grow in vast underwater meadows.

Affiliated species

SAV species form the foundation of many marine, brackish, and freshwater communities around the world, including in the Chesapeake Bay. At their base and below the substrate, SAV provides habitat to benthic invertebrate species, including microscopic zooplankton, blue crabs and other shellfish, amphipods, isopods, and shrimp. Invertebrates such as sea scallops cling to SAV stems and leaves, which provide them not only with substrate to attach to, but also shelter from potential predators. Algae (called epiphytic algae) also grow on the leaves of many SAV species. These algae, along with other microorganisms, are a source of food for fishes and other predators that inhabit SAV communities.

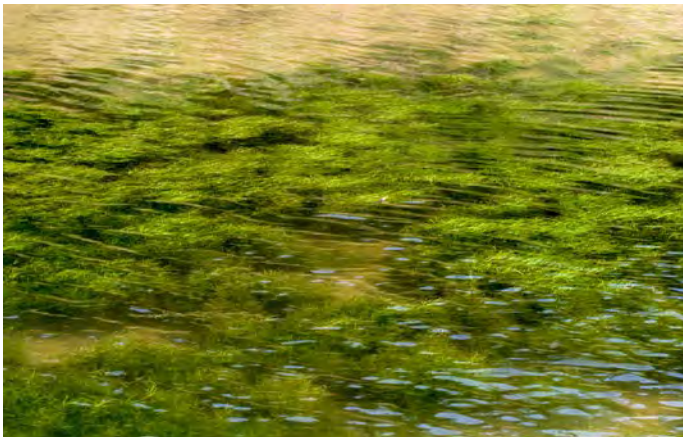

Larval fishes take advantage of the shelter provided by SAV beds, using them as nursery habitats and consuming abundant smaller organisms and detrital materials. Juvenile and adult fishes also find shelter and food in SAV, inhabiting it either permanently or ephemerally. They consume smaller organisms and sometimes the SAV plants themselves. Waterfowl, both migratory and resident, find nutrition in the seeds, leaves, and roots of SAV, in addition to any endemic shellfish and fish species.

Ecosystem services

SAV beds impart a wide diversity of ecosystem services beyond providing nursery habitat and feeding grounds for many commercially important fish and shellfish species. They absorb massive amounts of carbon, which is a crucial function in our warming world. They take up excess nutrients and trap sediment,

keeping water clear. They also protect shorelines by slowing tidal action and helping control for erosion.

Of critical importance is SAV's contribution to blue carbon, which is a term that describes any carbon that is captured and sequestered by the world's marine and coastal ecosystems. As these underwater plants photosynthesize (turn sunlight into energy), SAV species, like terrestrial plants, take in carbon dioxide to make plant tissue. However, carbon sequestration in SAV beds differs from sequestration in terrestrial ecosystems. On land, carbon is stored almost entirely within the tissue of individual plants. When a terrestrial plant dies, its stored carbon is released back into the atmosphere via decomposition. SAV stores carbon in a similar manner while alive, but when the plants die, the carbon released from their decaying tissue accumulates in the sediment. Carbon can remain buried in the sediment for decades or longer. In this way, SAV is vital to mitigating climate change. Meadows of underwater grasses are responsible for more than 10% of all carbon buried in the global

oceans each year, and per unit area, they store up to twice as much carbon as the world's temperate and tropical forests!

In addition to mitigating climate change through carbon sequestration, SAV absorbs excess nutrients, including phosphorus and nitrogen, from the water. This reduces the abundance of phytoplankton and the risk of harmful algal blooms, which feed on excess nutrients in the water column. SAV also traps sediment from the water column. This reduction of excess nutrients and suspended sediments improves water clarity, allowing for better light penetration and increased SAV productivity. The more productive an SAV bed is, the more productive the whole SAV ecosystem is. Productive SAV ecosystems provide sustenance for filter feeders, microorganisms, and small herbivores, which in turn sustains a food web that is comprised of small predators, large fishes, and aquatic birds.

SAV is thought of as an ecosystem engineer because it modifies the surrounding physical environment. The physical structure of SAV dampens wave and current energy, reduces wave height, and stabilizes sediment by trapping it in its root system. This helps prevent shoreline erosion and provides storm surge protection for coastal communities. Additionally, SAV oxygenates the waters around them through photosynthesis, benefiting all of the organisms that inhabit the nearby environment.

Overall, ecosystem services provided by SAV are important not only to the natural world, but also to humans. SAV beds support communities of commercially important fish and shellfish and prevent algal blooms that could harm both aquatic organisms and people. SAV also protect coastal communities from erosion and storm surge. Perhaps most critically, SAV beds store larger amounts of carbon, for longer periods of time, than terrestrial plant systems, making SAV beds an extremely important component of climate change mitigation.

Threats

Over the last 100 years, large amounts of SAV, including one quarter of seagrasses, have been lost worldwide. Although past declines in SAV were attributed to disease and storm events, today's threats are mainly human driven. Poor water quality, due in part to nutrient pollution, and climate change are the two greatest contributors to declining SAV habitats, but other human-driven threats include damage caused by boat propellers, dredging, and excessive shoreline armoring (the installation of bulkhead and rip rap, which changes wave energy and affects SAV).

Water quality poses such a great threat to SAV because these plants have high light requirements, and declines in water quality reduce the amount of light that penetrates the water column. The greatest cause of poor water quality is nutrient pollution. As stormwater runoff from developed areas enters coastal and estuarine systems, it introduces excess nitrogen, phosphorus, and sediment to the waters. This reduces water clarity and stimulates the growth of phytoplankton floating in the water and attached to SAV blades. This increase in phytoplankton density reduces the amount of sunlight that reaches SAV, which inhibits photosynthesis and ultimately results in reduced productivity or large-scale die-offs.

The effects of nutrient pollution on SAV are exacerbated by rising water temperatures. Recent declines in some species of SAV, like eelgrass, are due in part to the nearly 3 degree Fahrenheit (1.67 degrees Celsius) increase in average summer temperatures. The combined effect of increasing temperatures and nutrient runoff pose a major threat to SAV and the communities that depend upon it.

SAV IN THE CHESAPEAKE BAY

A history of SAV research in the Chesapeake Bay

Some of the earliest observations about Chesapeake Bay SAV are well-preserved in herbarium collections and in the journals of early explorers, but frequent, extensive, or thorough studies of Chesapeake Bay SAV were not conducted until more recently.

As the human population expanded in the Chesapeake Bay watershed throughout the mid-1900s, water quality deteriorated and negatively affected the Bay's overall abundance of SAV. By the late 1960s and early 1970s, SAV loss became a major concern as degraded habitats could no longer provide ecosystem services. Then in 1972, Tropical Storm Agnes swept through the region, caused significant damage and flooding, and destroyed more

than half of the remaining SAV in the Bay. The following year, U.S. Senator Charles Mathias called for and appropriated congressional funding for a study to analyze the degradation of the Chesapeake Bay ecosystem. The study officially took place between 1976 and 1982. The final report determined that excess nutrient pollution from the Bay's watershed was the primary culprit for increasingly poor water quality and loss of aquatic life.

Motivated by the results of the study, the Chesapeake Bay Program was formed in 1983. In 1984, a Bay-wide aerial SAV survey began, the first of what would become an annual event. Although aerial photography had been collected from regions of the Bay prior to 1984, a comprehensive Bay-wide survey had never been conducted. At the time of the first aerial survey, only about 38,000 acres of SAV were observed.

The documentation of the Bay-wide decline of SAV and its associated ecosystem services led to a spike in academic and public concern over SAV health, as well as the health of the Bay overall. Prior to the implementation of the SAV survey, only a couple of dozen papers had been published about Chesapeake Bay SAV. Both the frequency and scope of research projects increased dramatically in the years following. Today, SAV research in the Bay spans such topics as species distribution and abundance, species diversity, reproductive ecology and genetics, impacts associated with land-use, the effects of climate change, trophic studies, and restoration science - all in part due to the positive impact of the survey.

The importance of SAV

SAV has long been recognized as an important component of a healthy Bay ecosystem. Beds of SAV provide food, habitat, and nursery grounds for a number of commercially, recreationally, and ecologically important finfish and shellfish, such as the Bay's iconic blue crab. Even resident and migrating waterfowl depend on SAV for food. Physically, SAV absorbs excess nutrients from the Bay, which reduces algae abundance, and it also reduces wave and current energy, which reduces shoreline erosion and promotes water clarity.

Threats to SAV

SAV in the Chesapeake Bay is vulnerable to multiple threats, but because SAV depends on light for photosynthesis, water clarity is the primary limiting factor for SAV productivity in the Bay. Watershed land use, in turn, is one of the primary determinants of water clarity in the Bay. Land use affects water clarity through

a number of pathways, including deforestation, agricultural expansion, and urban development. All pathways contribute sediment and nutrient pollution (in the form of excess nitrogen and phosphorus) to the Bay's waters. In the Chesapeake Bay, nutrient pollution stems from a number of sources, including overburdened wastewater treatment plants, urban stormwater runoff, and agricultural runoff (particularly from fertilizers and manure).

Suspended sediments reduce light directly by increasing the turbidity, or cloudiness, of the water, while excess nutrients lead to algae growth. Algae can grow in very large forms (like sea lettuce or kelp) or very small forms (like phytoplankton). Large-form algae, generally called macroalgae, compete with SAV for space and can block out light that would otherwise reach SAV tissue. In high densities, macroalgae can smother SAV. Small-form algae, on the other hand, blocks light from reaching SAV by "blooming" in the water column (e.g. phytoplankton) or growing directly on SAV leaf-blades as epiphytes.

In addition to reduced water clarity from nutrient and sediment pollution, other threats to Chesapeake Bay SAV include:

1. Shoreline armoring, which affects SAV by altering near-shore wave energy.
2. Boating, which can lead to propeller scarring of SAV in shallow water.
3. Climate change, which includes a number of threats ranging from the introduction of new pathogens and increased heat stress, to intensified storm events and longer-term changes to salinity and sea level.

SAV in the Chesapeake Bay has experienced fluctuations in its abundance due to various threats. Continuing restoration efforts are and have been working to mitigate these losses, especially through addressing the threat of nutrient pollution. For example, the Chesapeake Bay Total Maximum Daily Load (TMDL), or pollution diet, aims to reduce the amount of nitrogen, phosphorus, and sediment entering the Bay by implementing Best Management Practices (BMPs) throughout the watershed.

One way the Chesapeake Bay Program partnership tracks its progress towards restoring the Bay is through various monitoring efforts like the Chesapeake Bay SAV Monitoring Program and *Chesapeake Bay SAV Watchers*. Through the Bay-wide SAV Monitoring Program, we know that in 2017 SAV reached its highest acreage ever recorded - close to 105,000 acres - showing that restoration efforts are paying off and that there's hope here and across the globe when sustained restoration efforts are prioritized.

Bay salinity regimes and effects on SAV distribution patterns

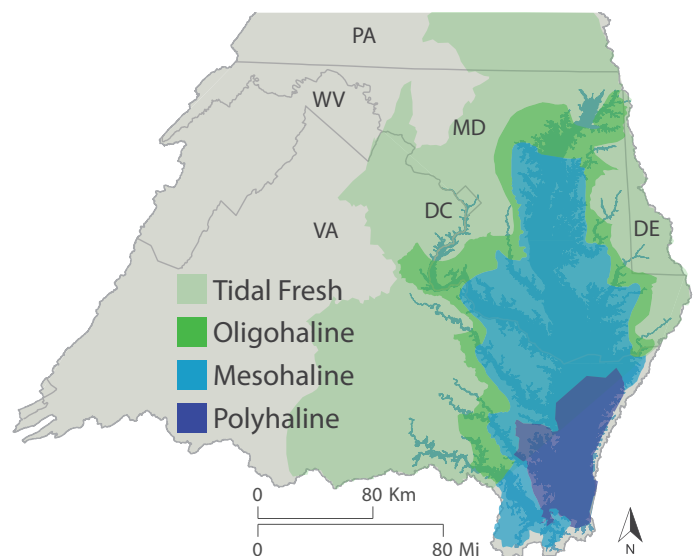
There are approximately seventeen species of SAV commonly observed in the Chesapeake Bay. While a number of factors influence SAV

species diversity and distribution throughout the Bay, including sediment type, wave energy, and light availability, their distribution is based primarily on their salinity tolerance.

There are four salinity zones in the Bay:

1. Polyhaline, the saltiest zone where salinity is greater than 18 ppt
2. Mesohaline, where the water is moderately salty and ranges from 5 - 18 ppt
3. Oligohaline, where the water is close to fresh and salinity ranges from 0.5 - 5 ppt
4. Tidal Fresh, where the water is fresh and the salinity is negligible at below 0.5 ppt

For the purposes of the *Chesapeake Bay SAV Watchers* project, the oligohaline and tidal fresh ranges will be jointly referred to as the oligohaline zone.

In the southern, saltier portion of the Bay, species diversity is low. There are only two species of SAV that thrive in that saltier (polyhaline) environment: eelgrass (*Zostera marina*) and widgeongrass (*Ruppia maritima*). As you move up the Bay and into only moderately salty (mesohaline) water, diversity increases but is still limited. Approximately four species live in this region, including widgeongrass (which has a very broad salinity tolerance), redhead grass (*Potamogeton perfoliatus*), sago pondweed (*Stuckenia pectinata*),

and horned pondweed (*Zannichellia palustris*). In the freshwater reaches of the Bay's tributaries and in the upper Bay proper (oligohaline, SAV species diversity increases dramatically. Some of the most common species you'll observe in those areas include wild celery (*Vallisneria spiralis*), water stargrass (*Heteranthera dubia*), Eurasian watermilfoil (*Myriophyllum spicatum*), *Hydrilla*, and a number of pondweeds (*Potamogeton* sp.) and naiads (*Najas* sp.).

As species diversity increases from the southern Bay to the upper Bay, so does the morphological and physiological diversity of the plants. The southern Bay species - widgeongrass and eelgrass - are relatively simple and resemble actual grasses, whereas several of the freshwater species grow in bushes and clumps, with leaves alternating on the stem or in a whorled arrangement. Diversity - both species and morphological - is important to the resilience of the SAV bed itself and also to the animals that use it as habitat. The more SAV species that are present, the higher the likelihood that some of those species will survive major environmental changes and stressors. Likewise SAV beds that contain higher levels of morphological diversity can provide habitat and refuge for a greater abundance and diversity of animal species.

Conservation efforts

To conserve and restore SAV in the Chesapeake Bay, the Bay Program's SAV Workgroup has adopted five primary management approaches in its SAV Management Strategy (<https://www.chesapeakebay.net/what/publications/2022-2023-sav-management-strategy>). The five management approaches are:

1. Support Efforts to Conserve and Restore Current and Future Submerged Aquatic Vegetation Habitat and Habitat Conditions
2. Protect Existing and Recovering Submerged Aquatic Vegetation
3. Restore Submerged Aquatic Vegetation in the Chesapeake Bay
4. Enhance Research and Monitoring in the Chesapeake Bay Watershed
5. Enhance Community Involvement, Education and Outreach

The Chesapeake Bay SAV Watchers Monitoring Program will directly or indirectly contribute to all management approaches for conserving and restoring SAV in the Bay! By helping Bay scientists collect SAV data, program participants will help protect SAV throughout the Bay. The more we know about what's out there, the better we can protect it. Participants will also help restore SAV! With more detailed species information, Bay scientists will be able to choose sites that will benefit the most from restoration efforts. Participants may also have opportunities to assist Bay scientists with actual restoration projects! And finally, research has shown that the more involved a community is with its environment, the more the individuals of that community do to help protect and conserve it.

INTRODUCTION TO THE VOLUNTEER MONITORING PROGRAM

What is the history of SAV volunteer monitoring in the Chesapeake Bay?

Citizen scientists and volunteers have played a major role in the conservation and restoration of Chesapeake Bay SAV over the last several decades. From the Chesapeake Bay Foundation's Grasses for the Masses program to the Riverkeeper groups and watershed organizations that monitor the Bay's tributaries, much of what we know about the distribution and abundance of various species of SAV is because individuals have gotten involved, volunteered their time, and shared their observations. Most recently, the Chesapeake Bay Program's SAV Workgroup has coordinated with citizen scientists and volunteer groups to conduct either ad hoc or organized surveys of SAV in tributaries throughout the Bay.

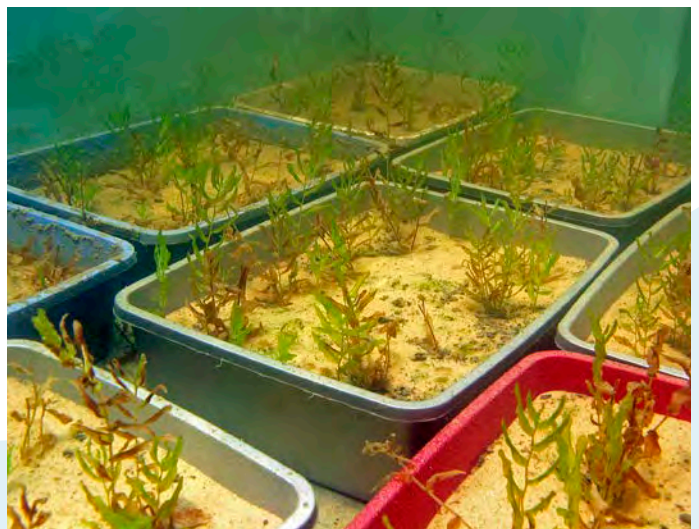
Why is it important to monitor SAV?

SAV is one of the most easily visible indicators of water quality and overall Bay health. Historically, it's been estimated that anywhere from 200,000 to 600,000 acres of SAV grew in the Bay. As the human population expanded throughout the watershed and land was developed, the Bay's water quality deteriorated and SAV disappeared from the waterways where it was once abundant. In response, the Chesapeake Bay Program and its partners have mounted a tireless effort to restore SAV by improving the Bay's water quality through various best management practices.

The ultimate Bay-wide restoration goal is 185,000 acres of SAV, with individual tributaries assigned specific restoration targets. The Chesapeake Bay SAV Monitoring Program conducts an annual aerial survey to determine how much progress we have made towards both Bay-wide and tributary-specific acreage goals, but the survey does not tell us everything we need to know about which species are

thriving in various locations, or where SAV beds are growing undetected by the aerial images. Having in-water observations gives Bay scientists key information about habitat characteristics such as species richness and diversity. These two measurements reveal how many species are present in an area, as well as their relative abundance, and that information in turn gives Bay scientists an idea of an SAV bed's resilience.

Where does the data go?

The Chesapeake Bay Program's annual SAV monitoring program has been ongoing since 1984 and is conducted by the Virginia Institute of Marine Science (VIMS). VIMS maintains a website where all SAV data is stored so that any Bay research scientist, environmental professional, or citizen can view and use it.

All of the data collected for the *Chesapeake Bay SAV Watchers* Monitoring Program gets entered into the VIMS SAV website as well, but first the data goes through the Chesapeake Bay Program's SAV Workgroup. Sending the data through the SAV Workgroup first allows the Workgroup to review which tributaries are best or least represented in the data. This pre-entry step also allows the Workgroup to monitor the number of citizen scientists or volunteers participating in data collection. Then the data

will be given to VIMS to load onto their website for public use. All volunteers participating in the *Chesapeake Bay SAV Watchers* Monitoring Program record their SAV observations on a standardized data sheet. Our monitoring protocol is therefore able to not only streamline SAV data entry, but also to standardize the data so that web users can more readily access a broader assessment of the Bay's SAV population.

How is the Chesapeake Bay SAV Watchers monitoring protocol set up?

The *Chesapeake Bay SAV Watchers* Monitoring Program offers two distinct monitoring protocols in order to accommodate the various monitoring needs, interests, and expertise of our volunteers. The Introductory Monitoring Program (Tier 1) is geared towards individuals

who are not affiliated with an official volunteer monitoring group. This program invites volunteers to submit opportunistic observations of SAV species using the *Water Reporter* app. Participation in the Introductory Monitoring Program is open to everyone. Training is not required in order to participate; however, volunteers are encouraged to attend SAV species identification trainings if possible. The Advanced Monitoring Program (Tier 2) is designed for individuals who are members

of official volunteer monitoring groups. This program involves more intensive data collection on a diverse number of parameters beyond SAV species, including Secchi depth, SAV density, shoreline type, other macrophytes, and more. Participation in the Advanced Monitoring Program requires training and certification.

How does the training and certification program work?

Volunteers who wish to participate in the Chesapeake Bay SAV Watchers Advanced Monitoring Program (Tier 2) must complete a training course and receive certification. The training and certification requirements vary depending on whether a participant is a member or leader of a volunteer monitoring program. Leaders of volunteer monitoring groups are required to complete an in-person training session with the Chesapeake Bay SAV Watchers Monitoring Program coordinator. This

training session includes an orientation on the monitoring protocol, during which participants practice how to identify SAV species and learn how to properly collect, record, and digitize data so that it is compatible with the VIMS SAV website and all its features. Participants will

be tested on their ability to complete these tasks at the end of the training session. Once volunteer monitoring group leaders complete the training session, they become “certified trainers” who can then train and certify members of their monitoring groups. Certified trainers are only required to complete one official Chesapeake Bay SAV Watchers training session in order to achieve certification, though we do encourage trainers to attend subsequent trainings as needed for review. Members of volunteer monitoring groups must complete a training as specified by their monitoring group coordinator in order to become “certified volunteer monitors”.

What materials are available for Chesapeake Bay SAV Watchers?

There are many resources available for Chesapeake Bay SAV Watchers participants. All materials can be viewed online at www.chesapeakebaysavwatchers.com and printed as needed.

Methods manual: includes background information on SAV and the Chesapeake Bay SAV Watchers Monitoring Program, detailed protocol for the Advanced Monitoring Program (Tier 2), safety information, an updated SAV species guide, and many other references.

instructions: detailed instructions for collecting and submitting Tier 1 data using the *Water Reporter* app.

Guide to the Introductory Monitoring Program (Tier 1)

All Chesapeake Bay SAV Watchers volunteers will use the Water Reporter platform to submit data for the Introductory Monitoring Program. It is recommended that volunteers collect and submit data using a smartphone equipped with the Water Reporter app. This section will review the steps involved in this process.

1. Open the Google Play Store.
2. Type "The Water Reporter" into the search bar to locate the app. A list of suggested results will appear as you type.
3. Select the Water Reporter app from the list to open its Play Store page.
4. Tap the "Install" button to download the free app to your device and install it.

1. Open the App Store.
2. Tap the magnifying glass icon in the bottom right corner to open the search bar.
3. Type "The Water Reporter" into the search bar to locate the app. A list of suggested results will appear as you type.
4. Select the Water Reporter app from the list to open its App Store page.
5. Tap the "Get" button to download the free app to your device and install it.

In order to contribute data to the Chesapeake Bay SAV Watchers Introductory Monitoring Program, all observers will need to create a user account. This can be done using the Water Reporter app on a smartphone or on the Water Reporter website at <https://www.waterreporter.org>. This section will review the steps involved in this process.



On a smartphone

1. Open the **Water Reporter** app and select "SIGN UP" to create a new account.
2. Enter your email address and a password. Use an address that you check regularly so that you receive an email notification when **Chesapeake Bay SAV Watchers** administrators or other users connect with you via the app.

Data sheet: volunteers should print this document (double-sided on waterproof paper if possible) and use it to record all field observations.

Pocket Field Guide: a pocket-sized SAV species identification guide that includes extra photos of other macrophytes.

BEST PRACTICES FOR DATA COLLECTION

How should site locations be selected?

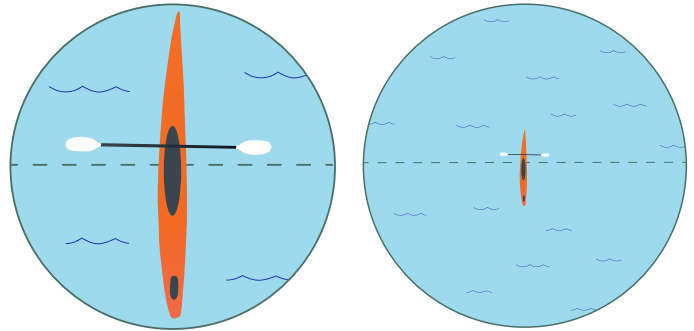
When sampling multiple sites in the same area, it is recommended that individual sites be spaced at least 15 meters apart from each other (about the distance across four lanes on an interstate). Site selection within a monitoring group is left to the discretion of the monitoring group coordinator or leader. When selecting sites, it may be helpful to consult the annual aerial SAV survey map on the VIMS website at <https://www.vims.edu/research/units/programs/sav/access/maps/index.php>. It is particularly valuable when volunteer-collected data can verify the aerial surveys. For example, volunteer-collected data could be used to either confirm the existence of SAV beds that appear on the map, or potentially reveal beds that were not captured in the aerial survey at all. Aerial surveys primarily capture the geographic extent and density of SAV beds but do not reveal other valuable information, such as the species diversity within the beds. Collecting this additional information is extremely important for management purposes. It is also essential to always confirm the accuracy of a site's recorded location. This can be done by double-checking GPS coordinates and recording coordinates in the correct format (see protocol).

What qualifies as a site?

Sampling circle

A sampling site is a circular area with a 3 meter diameter (about the length of a recreational kayak). The GPS coordinates associated with a sampling site represents the center point of a sampling circle. When collecting data at a site, the observer should be positioned at the center of the sampling circle before proceeding to

monitor the area surrounding them (1.5 meters - or about 5 feet - in all directions) for all types of data, excluding the long-range data parameters.

Long-range data collection

At each site, observers collect most of the required data by visually inspecting the area within the sampling circle. For some parameters, it is necessary to look beyond the perimeter of the site itself. Long-range data parameters include the following: 1) shoreline type, 2) visible shoreline erosion, 3) marine debris, and 4) other human impact. When collecting these four types of data, observers should expand their sampling circle from a 3 meter diameter to a 200 meter diameter. After establishing this larger circle, begin collecting data for the surrounding area, again, starting from the center of the circle (100 meters in all directions, or about the length of a football field). If a sampling site is not located within 100 meters of a shoreline, indicate this on the data sheet.

When and how often should I sample?

For the purposes of this monitoring program, it is more valuable to sample a greater number of sites once or twice a year rather than frequently sampling a smaller selection of sites. Sampling should be done at least once a year during the summer growing season when the SAV reaches peak biomass and reproductive structures (e.g. seeds and flowers) are visible. Grasses peak earlier in the more southern areas of the Bay and later in the northern regions. Generally, SAV surveys in the southern polyhaline region of the Bay should be conducted in May. In the moderately salty, mesohaline mid-Bay, sampling should occur in July or August when reproductive structures are most abundant in this region. If time and capacity permits, an early spring (April) survey would also be beneficial in the mesohaline to capture the distribution and abundance of horned pondweed. In the freshwater regions of the upper Bay and tributaries, SAV peaks and begins reproducing in August and/or September, therefore sampling should take place within this time frame. The exact timing of peak biomass and reproductive activity varies slightly depending on summer temperatures and precipitation, so these dates should be considered as general guidelines.

What are the best sampling conditions?

To increase data quality and value, it is important to collect data during optimal sampling conditions. When deciding whether or not to go out in the field to sample, there are a few factors to consider. Data collection should be completed when SAV visibility is maximized. Observers should sample at low tide and on a sunny day with little wind, following a period of minimal rainfall.

Rain

Rain increases the turbidity, or murkiness, of the Bay for days, or even weeks, after a precipitation event. When water is cloudy, it is hard to see SAV and even more difficult to accurately estimate SAV density. Sampling should be completed when the water is at its clearest - after a week of dry weather. Sampling should never be done during rainfall or in the days following significant rainfall.

Tide

The depth of the water has a large effect on the visibility of SAV. SAV is much easier to see at low tide; so sampling should be completed when the water levels are low. Observers should check the tide chart before planning a sampling trip. Tide charts can be located on the NOAA website (<https://tidesandcurrents.noaa.gov/stations.html?type=Water+Levels>), the MD DNR website (<http://dnr.maryland.gov/Fisheries/Pages/Tide-Finder.aspx>), or by using apps such as [Tide Charts](#) or [Tide Alert \(NOAA\)](#).

Wind

On windy days, it can be difficult (and possibly dangerous) to maintain a steady position on a small boat or kayak in order to accurately monitor a specific site. Wind can also disrupt the surface of the water, decreasing the visibility of SAV below the surface. To safely

and accurately collect data, observers should sample on days with low wind speeds and avoid sampling when small craft advisory warnings have been issued.

Sun

Light also affects the visibility of underwater grasses. Sunlight penetrates the water column and makes grasses easier to see, but too much light can produce a glare on the surface of the water, which can also interfere with sampling. Ideally, observers should sample on sunny days when the sun is not directly overhead.

How should I collect SAV specimens?

When surveying SAV, you will most likely be on a motorboat, in a canoe or kayak, wading in from shore, or observing SAV around your dock. In all cases, you should aim to disturb the SAV bed as little as possible. In order to take good pictures of the species observed, though, you will need to collect some samples. Whenever possible, avoid uprooting SAV. Oftentimes there will be uprooted or broken SAV material floating at the surface. If that's the case, take those samples for your pictures. If you can't find any plants that are already detached, you can grab some either with your hand or by using a rake. Bushy species, like common waterweed or many of the naiads, fragment easily without disturbing the roots. They are simple to collect without causing much disturbance. Other

species, like wild celery or widgeongrass, are more likely to come up from the root when collected for sampling; so take care to only pull up one plant of each species for your picture(s). When possible, such as when the leaves are growing to the surface, you can use two hands to break off the upper portion of the plant for your picture to avoid disturbing the roots.

How can I stay safe while sampling?

As with any type of outdoor work or water-based activity, there are some risks associated with monitoring SAV. Therefore, it is important that all volunteers take precautions to keep themselves and others safe during monitoring activities. *Chesapeake Bay SAV Watchers* does not require volunteers to sign any liability waiver forms, but if you are monitoring as part of a group monitoring effort (e.g. for a Riverkeeper monitoring group), they may require you to sign a waiver form. Safety during monitoring activity is the responsibility of both the individual volunteers and volunteer monitoring groups. Below are several recommendations and general precautions that all SAV monitors should follow when conducting any type of volunteer monitoring activity:

- Always alert someone when heading out to monitor. Ensure that someone knows where you are going, when you intend to return, and what to do if you do not return as expected. This is called a Float Plan. There are several example float plans available online. Check out this website for simple instructions on how to create one: <https://www.boaterexam.com/boating-resources/filing-a-float-plan/>.
- Always wear a life jacket.
- Pack a first aid kit, and have a safety plan in place in case of emergency. Share any relevant personal health information, such as any known allergies or heart conditions, with your sampling partner. Know where the nearest medical facility is, and have

emergency contact and medical insurance information on hand just in case.

- Monitor with at least one partner whenever possible. Follow the “buddy system”!
- Pack plenty of water when you monitor. Never drink water from the Chesapeake Bay or any of its tributaries and streams.
- Dress appropriately for outside work. Wear a hat, sunglasses, water shoes, sunscreen, and insect repellent.
- Do not touch water that you believe may be contaminated (if you see or smell any indication of a sewage spill, oil spill, harmful algal bloom, or fish kill, for example). Do not enter the water after large rain events or if you suspect that the water may be severely polluted. Always wash your hands and shower after monitoring, and avoid water contact if you have open cuts, sores, or wounds.

- Check weather reports before leaving for monitoring. Do not monitor if severe weather is predicted (strong winds or current, lightning, heavy rain, etc.). If you are on the water and a storm blows in before you are able to get back to your point of entry, go to the nearest shoreline or dock to take shelter.
- Familiarize yourself with the monitoring protocol and noted precautions before going out to monitor.
- Access sampling sites by using public access points. Always obtain permission of the landowner when monitoring SAV on private property.

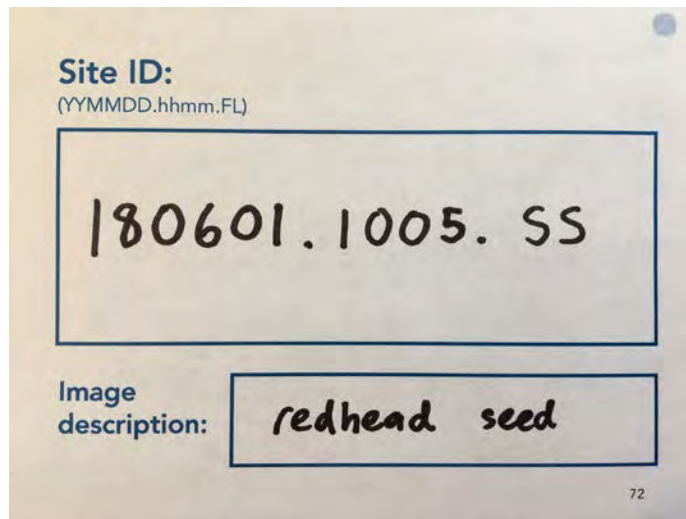
How can I take high-quality photos?

High-quality photos are valuable because they can be used to confirm observations. Providing this method of quality assurance makes data much more likely to be used in a greater variety of contexts, including in scientific reports that inform policy and management decisions. In fact, some data parameters, such as SAV species, density, and flowers or seeds, can only be used by professional scientists if there is also photographic evidence. For this reason, many volunteer monitoring programs, including this one, require observers to submit photographic data along with their recorded observations. Here are some ways to increase the quality of your photos.

Include essential site information in the picture

Observers must include the Site ID (see protocol for formatting instructions) and a brief image description in each photo. An easy way to do this is to fill in the back side of the Pocket Field Guide and include the guide in every photo from a particular site. When the site number and image description are included in the photo, there is less of a need to rely on

only the photo's preserved metadata (photo name, date, etc.) to identify which pictures are associated with a particular sampling site.

Think about lighting and focus

Whether photographing plant features to identify a species or confirm the presence of flowers or seeds, make sure that the SAV specimen is well lit and the image is in focus. Proper lighting and focus will increase the likelihood that the photo can be a useful quality assurance tool.

Photograph unusual or distinguishing characteristics

Remember, the purpose of taking these photos is so that other volunteers and SAV experts can refer to a photo to confirm a recorded observation. Consider the defining characteristics of particular SAV species, and make sure that someone could potentially use your photo to identify an individual species with reasonable confidence. When removing SAV from the water to set up a photograph, place the specimen against a light-colored surface, such as a clipboard or piece of paper, with the leaves and stems spread out. This will allow others to easily distinguish unique leaf arrangements. If present, include seeds, fruits, and flowers in your photographs. Include close-up shots of the SAV when necessary. For

any data parameters that do not require an image, consider taking a photo when observing anything unusual, rare, or concerning.

Photographs should always include any flowers, seeds, or other characteristic structures that can be used to either confirm species identification or learn more about the reproductive success of the SAV bed. (Brooke Landry).

Introductory Monitoring Program (Tier 1)

Observations using Water Reporter

Overview:

Record the species of SAV present using the *Water Reporter* platform.

Significance:

SAV species identification provides additional information about the environment and resiliency of the plants that live there. By recording species, changes in SAV can be monitored along with changes in the environment. Knowing how species are changing can guide decisions regarding management and restoration.

Equipment:

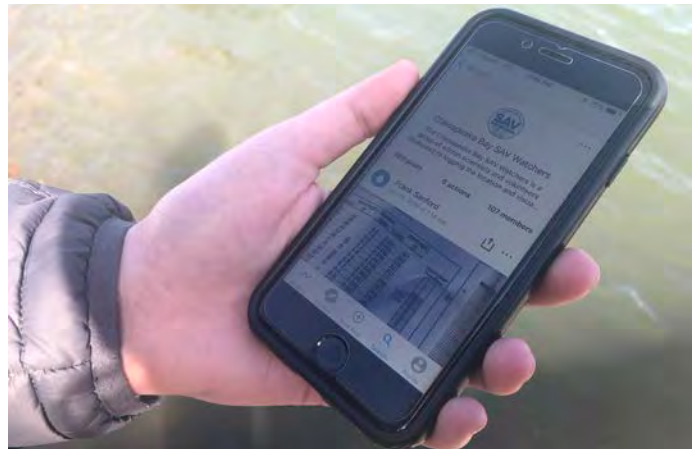
On-site reporting - SAV species guide or Pocket Field Guide, waterproof phone pouch, and a smartphone equipped with the *Water Reporter* app, GPS location services, and a camera.

Off-site reporting - Computer with internet, *Water Reporter* website, paper, pencil, watch or clock, camera, GPS-enabled device, and SAV species guide or Pocket Field Guide.

Method:

Volunteers who participate in the *Chesapeake Bay SAV Watchers* Introductory Monitoring Program will be asked to submit the following data for each monitoring site: GPS location, sampling date, sampling time, and a list of the SAV species observed, in order from most abundant to least abundant. Photos of the observed SAV species must also be submitted as part of any observation. All volunteers will use the *Water Reporter* platform to submit Tier 1 data. There are two ways to collect and submit monitoring data using *Water Reporter*. The most straightforward approach is on-site reporting where you submit observations at the monitoring site using a smartphone equipped

with the *Water Reporter* app. If a volunteer is uncomfortable doing this, they may rely on off-site reporting, or submitting SAV data to the *Water Reporter* website after the sampling event, using a desktop or laptop computer. In either case, observers must set up a personal account on *Water Reporter*, which should include the observer's name and, if applicable, the monitoring group. All observers must also join the *Water Reporter* group *Chesapeake Bay SAV Watchers*. Detailed and updated step-by-step instructions on how to use the *Water Reporter* app or website can be found on the *Chesapeake Bay SAV Watchers* website at www.chesapeakebaysavwatchers.com.

Pro tips:

- If you cannot identify the plant to the species level, identify the genus and make sure to take a clear picture so that the species can be identified by SAV experts.
- The submitted picture should be a close-up shot that highlights plant characteristics for species identification. See the previous section of this manual for more details.
- If multiple species are observed at one site, include all species in your uploaded photo. If you are unable to include all observed species in one photo, you should upload one photo and then include additional photos as comments to your original post.

Advanced Monitoring Program (Tier 2)

Basic information

Overview:

Denote who, where, and when the data were recorded.

Significance:

In order for data to be useful and reliable for Chesapeake Bay data analysts and scientists, information on how and where observations were made must be recorded. Recording basic personal information like the data collector's name and monitoring group can be useful if there are any problems or questions regarding data collection or entry. The sampling time and date are important for bookkeeping and any future data interpretation. For example, SAV abundance depends on other factors such as light and temperature, both of which fluctuate throughout the year. Recording the date addresses some of the annual variation, and recording the time of day accounts for the changing tides. Additionally, observers will measure water depth at all monitoring sites, but that measurement changes as tides go in and out. Depths measured during fieldwork can be standardized with our knowledge of tide schedules. Most importantly, the location of the monitoring site needs to be as precise as possible in order to accurately track both Bay-wide SAV patterns, as well as local-scale changes over time. Finally, the unique Site ID will provide a means to organize all information, including photos, based on the individual sampling event.

Equipment:

Data sheet and pencil, GPS-enabled device, watch or clock, camera, spare paper or Pocket Field Guide, and dry erase marker.

Method:

1. Record the following information at the top of the data sheet. This information will be the same for all three sampling sites on the data sheet:
 - a. Observer name and monitoring group. This can be done before going to the field.
 - b. Date (DD/MM/YYYY) of sampling.
 - c. General description of area where sampling occurs (e.g. tributary name)
 - d. Time (hh:mm; use 24-hour clock) of high tide and low tide. Use a tide chart to determine tide times.
2. Record the time (hh:mm; use 24-hour clock) at which data collection at a monitoring site begins.
3. Record GPS points.
 - a. Use the Latitude Longitude Coordinate System, and record the location in decimal degrees to six decimal places (DD.DDDDDD, DD.DDDDDD).
 - b. Triple-check coordinates for accuracy!
 - c. For more information on the Latitude Longitude Coordinate System, visit https://maptools.com/tutorials/lat_lon.
4. Record the unique Site ID. The ID helps keep all data organized according to sampling event. The ID includes the sampling date, time, and observer's initials (first, last) and should be recorded using the specified format (YYMMDD.hhmm.FL).
 - a. Ex: 180823.1524.JD signifies a site that was observed on Aug 23, 2018 at 3:24pm by Jane Doe.
 - b. If more than one person is present when monitoring a site, choose one person's initials to use on behalf of the sampling team.

5. Write down the Site ID on the back of the Pocket Field Guide using a dry erase marker (or on a spare piece of paper using a pencil).
6. Record observations for Secchi depth, water depth, SAV density, SAV species, epiphytes, other macrophytes, SAV flowers and seeds, canopy height, bottom sediment description, shoreline type, visible shoreline erosion, marine debris, and other human impacts. See instructions below for parameter-specific instructions.

Pro tips:

- Check that your GPS device is set to measure location using the Latitude Longitude Coordinate System. GPS should be recorded as decimal degrees only, and *never* as Degrees/Decimal Minutes or Degrees/Minutes/Seconds. If using a handheld GPS unit, consult the device website or instruction manual to adjust settings if necessary.
- GPS points can be retrieved and confirmed using a handheld GPS unit or a standard smartphone. See the Appendix for “How to retrieve a GPS location using phone”. You can also use the *Water Reporter* app to retrieve GPS coordinates.
- GPS points can very easily be written down incorrectly. Observers should triple check the data sheet against the GPS coordinates on their phone or computer and save coordinates digitally whenever possible.

Secchi depth

Overview:

Measure the distance between the water surface and a Secchi disc lowered to the limit of visibility.

Significance:

SAV depends on light for photosynthesis; so aquatic plants are limited to areas where enough light can penetrate the water column and reach the plant. Clear water easily lets light travel through, but suspended sediment, algae, and other materials can reflect and trap light that would otherwise reach plants growing from the bottom. Water that has a greater Secchi depth is more transparent and allows more light to pass through, while water with a smaller, shallower Secchi depth is murkier and blocks light from reaching plants growing on the bottom. Knowing the Secchi depth at a site allows us to determine to what extent the site is suitable for SAV growth and restoration.

Equipment:

8" Secchi disk with an attached measuring tape or pre-marked rope.

Method:

**Note: Measure the Secchi depth before entering the water or taking any other measurements that might disturb bottom sediments or the water column.*

1. Remove sunglasses or snorkeling mask, and turn so you are facing away from the sun.

2. Lower the disk slowly off the shady side of the boat.
3. Continue lowering the disk until the disk just barely disappears from sight. Based on the length of the line that is submerged beneath the surface of the water, note the depth reading.
4. Slowly raise the disk towards the surface of the water until it barely reappears, and note the depth reading.
5. Average the two depth readings to calculate the limit of visibility (index of transparency) and record this calculation to the nearest centimeter.

Pro tips:

- Sometimes the Secchi depth is equivalent to the total water depth of a site (the Secchi disk is still visible even when it is resting on top of the sediment). If this occurs, indicate this by marking "B" for bottom on the data sheet in place of a Secchi depth measurement.
- Make sure that the tape is positioned straight down from the surface. Sometimes the current positions the line at an angle, and influences the measurement.
- If there is wave action at your site, estimate the limit of visibility based on the midway point between the waves' highest part of the crest and lowest part of the trough.
- If dense SAV growth obscures the Secchi disk or prevents the disk from lowering, use a paddle or your hand to gently push SAV plants aside until an accurate, unobstructed Secchi depth reading can be measured.
- If you do not have access to a Secchi disk with a measuring tape, you can also use a Secchi disk attached to a rope. Before monitoring, use electrical tape and either a tape measure or yardstick to mark measurements onto the rope. Include enough markers so that you can measure the depth to the nearest centimeter.

Water depth

Overview:

Measure the water depth from the bottom sediment to the surface of the water.

Significance:

Water depth influences whether or not a habitat is suitable for SAV growth. SAV depends on light for photosynthesis; so plants are limited to areas where enough light can penetrate through the water to reach the bottom. When water is deep, less light reaches the bottom, and plants have a harder time providing enough energy for themselves. However, plants can also be light-limited when water is murky, or turbid. That is why measurements of water depth and Secchi depth complement one another.

Equipment:

8" Secchi disk with an attached measuring tape or pre-marked rope.

Method:

1. Slowly lower the Secchi disk into the water until the disk is touching the bottom, and the line just barely becomes slack.
2. Based on the length of the line that is submerged, record the depth reading in centimeters.

Pro tip:

- When the bottom has been reached, raise and lower the line a few centimeters and use the tension of the measuring tape to confirm the location of the bottom.

Total SAV density

Overview:

Indicate whether or not SAV is present at a site and provide a measure of density.

Significance:

Density is a measurement of how much SAV covers the bottom sediment at a particular site. Highly dense beds generally have more SAV shoots growing per unit of area and/or thicker leafy vegetation coverage when viewed from above. SAV density can serve as an indicator for a meadow's overall health, providing information on how well it can endure storms and how suitable it is for animal habitat. Density can also affect an SAV bed's ability to provide various ecosystem services such as protecting shorelines from erosion and trapping sediment.

Equipment:

None required.

Method:

1. Estimate the average overall percentage of SAV cover. Scan the vicinity to get a better idea of the average coverage for the site.
2. Record the total estimated SAV density category using the following options:

Category 0: Absent

Category 1: < 10% coverage

Category 2: 10% to < 40% coverage

Category 3: 40% to < 70% coverage

Category 4: 70% to \leq 100% coverage

Pro tips:

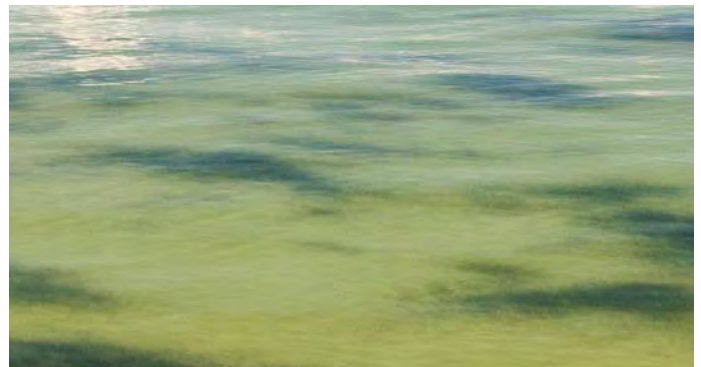
- Normally measuring density requires a quadrat, but to minimize bulky equipment it has been left out of this protocol. The unit of measure will be the sampling site, or the 3 meter sampling circle around your boat.
- SAV density should take into account only SAV that is rooted into the sediment,

rather than uprooted and floating at the surface of the water.

- Density should be estimated at low tide when SAV is most visible.

SAV species

Overview:

Identify species of SAV present at a site.

Significance:

SAV species identification provides additional information about the environment and resiliency of the plants that live there. The environmental setting, including water clarity, nutrient abundance or limitation, salinity, sediment type, and wave energy, determines whether or not SAV can grow at a site and which species may be present. For example, freshwater species like water stargrass (*Heteranthera dubia*) are unlikely to be found at the mouth of the Chesapeake Bay where the water is typically salty. In this way, the type of SAV is a natural indicator for the condition of the local environment.

As environmental conditions change, so can the species of SAV. When multiple SAV species inhabit an area, it is more likely that at least one of those species will survive changing conditions. Because of this, increased SAV diversity often means increased resilience for a site. When diversity is low, an SAV meadow is more vulnerable to a variety of stressors, such as disease. By recording species over time, changes in SAV can be monitored along with changes in the environment. Knowing how species are changing can guide decisions regarding management and restoration.



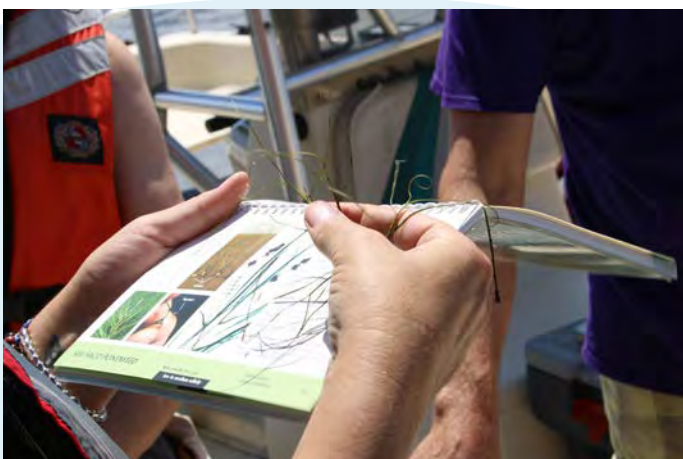

Equipment:

Camera, SAV species guide or Pocket Field Guide.

Method:

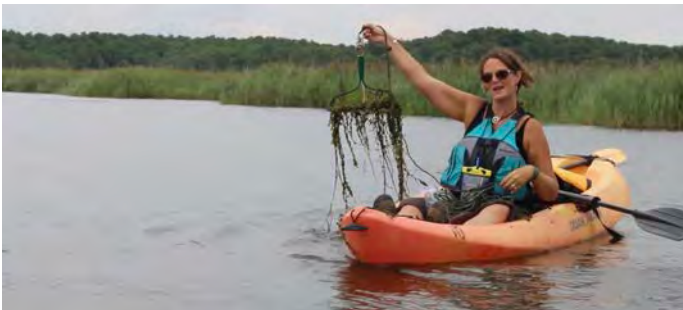
1. Collect enough SAV plants for species identification.
2. Use an SAV guide (the SAV guide in the protocol booklet, Pocket Field Guide, or the *Water Reporter* app) to identify which species of SAV are present at your site. If you cannot identify the plant to the species level, identify the genus, and make sure to take a good, clear picture so that the species can be identified by professional scientists.
3. Record all of the species present at the site, listing them from most abundant to least. Use the species abbreviations provided on the data sheet to record observed species.
4. Take a photo of SAV specimens collected from the site. If flowers or seeds are observed, include them in the photo. Also make sure to include the written Site ID and image description in the photo and note the image number or a brief image description on the data sheet.



Volunteers should use a SAV species guide to identify the species of SAV present at each monitoring site. (Sky Swanson)

Pro tips:

- Pictures should be taken close up, highlighting plant characteristics for species identification. Remove SAV from the water and photograph it against a light-colored surface, such as a clipboard or piece of paper, with the leaves and stems spread out so that leaf arrangement can be distinguished. If present, include seeds, fruits, and flowers in photograph. If multiple species are observed at one site, include all species in your photo or take multiple photos.
- Some SAV genera contain multiple species that look similar (e.g. *Najas gracillima* and *Najas flexilis*, or slender and northern naiads respectively). For these species, if you are having trouble identifying an SAV specimen down to the species level, list only the genera (e.g. *Elodea* sp., *Myriophyllum* sp., *Naiad* sp., and *Potamogeton* sp.).

Epiphytes

Overview:

Record observations of epiphytes at the monitoring site.

Significance:

Epiphytes are small organisms, often algae, that grow on the surface of SAV leaves and stems. When nutrient concentrations are high, epiphytes can grow dense enough to coat SAV leaves, blocking the light necessary for photosynthesis. Epiphytes compete with SAV for nutrients, light, and space. They often win when nutrients are plentiful. Thus, monitoring epiphytes found in SAV meadows aids in our understanding of SAV status and environmental conditions.

Equipment:

None required.

Method:

1. Using the SAV specimens already collected, scan the leaves for epiphytes.
2. Record the presence or absence of epiphytes by checking the appropriate box on the data sheet. Volunteers should indicate that epiphytes are "Present" when more than 25% of the SAV specimen is covered in epiphytes, and "Absent" when there is less than 25% coverage.
3. (Optional) Add notes regarding color, texture, thickness, etc.

Other macrophytes

Overview:

Record observations of drift or benthic macroalgae, *Lyngbya*, or emergent plants present at the monitoring site.

Significance:

Macroalgae are macrophytes found in fresh or salty water depending on the species. Macroalgae can be green, brown, or red. They can be found growing anchored to a hard surface, such as a log or a rock, or free-floating in dense mats should they detach. Unattached, free-floating mats of macroalgae, such as *Ulva*, continue to grow as they drift in the water column, and they easily get caught in SAV. When this happens, free-floating macroalgae can block light from reaching the underlying aquatic plants. Macroalgae is a natural part of marine and aquatic ecosystems, but they can grow quickly when large amounts of nutrients are present in the water. If macroalgae is present in abundance, it may be an indication of poor water quality.

Lyngbya is a type of cyanobacteria, or photosynthetic bacteria, that sometimes contains toxins. Under certain conditions, *Lyngbya* can overrun SAV or even block light by forming dense, floating mats on the surface of the water. *Lyngbya* can cause skin irritation for humans, adversely affect wildlife, and disrupt food-web dynamics. Sometimes it can be difficult to differentiate between mats of *Lyngbya* and mats of macroalgae.

Macroalgae and *Lyngbya*, like epiphytes, compete with SAV for nutrients, light, and space and can be an indicator of poor or changing water quality.

Emergent plants are those that are rooted under water but have leaves and stems either floating on the surface of the water, like lily pads, or extending out of the water, like reeds. Emergent plants are common along shorelines and in marshes, but some, like water chestnut

and American lotus, extend into open water and compete with SAV for space, nutrients, and light. In the Chesapeake Bay, water chestnut is an invasive species that is actively managed by state and local agencies and organizations. *Chesapeake Bay SAV Watchers* volunteers will collect data on two types of emergent plants: water chestnut and lily pads.

Please see the appendices for more images and information about other macrophytes.

Equipment:

Camera

Method:

1. Note any macroalgae or *Lyngbya* found at the site or collected during SAV monitoring.
2. If macroalgae or *Lyngbya* are present, estimate density using the four point scale:

Category 0: Absent

Category 1: < 10% coverage

Category 2: 10% to < 40% coverage

Category 3: 40% to < 70% coverage

Category 4: 70% to ≤ 100% coverage

3. Add additional notes on macroalgae identification if known.
4. Note any emergent plants found at the site or collected during SAV monitoring.
5. Record the presence or absence of emergent plants by checking the appropriate box on the data sheet. Add additional notes on emergent plant identification if known.
6. If any macrophytes are observed at the site, take a photo of the specimens. Make sure the written Site ID and image description is included in the photo and note the image number or a brief image description on the data sheet.
7. (Optional) Add notes regarding species, color, or density.

SAV flowers and seeds

Overview:

Indicate whether or not SAV flowers or seeds are present at the monitoring site.

Significance:

SAV reproduce in a number of ways, but one of the most visible is through the production of flowers, seeds, or seed pods that float on or near the surface of the water. Because identifying SAV species can be tricky by looking at the stems and leaves only, SAV flowers and seeds are one of the best ways to identify the species present.

Equipment:

Camera

Method:

1. Scan the stems of growing SAV or any specimens collected.
2. For each observed species, record the presence or absence of SAV flowers or seeds by checking the appropriate box on the data sheet. Add additional notes if necessary.
3. Remember to always take a photo of the flowers or seeds for documentation. Make sure the written Site ID and image description is included in the photo, and note the image number or a brief image description on the data sheet.

SAV at surface

Overview:

Indicate whether or not SAV reaches the surface of the water at the monitoring site.

Significance:

The canopy height of underwater plants is indicative of the species present and the environment in which they grow. Sunlight, nutrient availability, current speed, and water depth can all influence SAV canopy height. The height of the canopy can then, in turn, change the environment; longer leaves and a more complex canopy can slow down currents enough to trap fine particles that sink and get incorporated into the sediment. Taller, more complex SAV meadows also provide habitat for animals seeking shelter from currents and predators. Tall and dense SAV beds can also slow current speeds and water circulation, which can sometimes decrease the amount of dissolved oxygen in the water.

Equipment:

None required.

Method:

1. Scan the site to determine if any SAV has grown to the surface of the water.
2. Record the presence or absence of SAV at the surface by checking the appropriate box on the data sheet.

Pro tip:

- If you observe SAV on the surface, determine if it is attached to a substrate before recording presence or absence. Observers should mark that SAV is present at the surface when the SAV is still rooted in the sediment. Observers should mark that SAV is absent at the surface when SAV is not present or the canopy height is below the surface.

Bottom sediment

Overview:

Indicate the type of sediment found at the site.

Significance:

The bottom of the monitoring site beneath the water column is called the sediment. SAV needs sediment to anchor and stabilize itself in moving water. Different SAV species prefer different types of bottom sediment, ranging from sand to mud. Peat-dominated sediments are also present in areas of the Bay. SAV abundance is generally limited in areas with peat as sediment. In this way, sediment type can help explain why certain species of SAV are present or absent in certain areas, which in turn helps managers and scientists prioritize specific areas of the Bay for SAV restoration.

Equipment:

Paddle, pole, or other long and rigid material.

Method:

1. Position yourself comfortably and securely over the monitoring site.
2. Extend your paddle, or other material, downward and push it through the top few inches of sediment. Take note of how easily the paddle penetrates the bottom sediment.
 - a. If the paddle penetrates the sediment relatively easily, it is soft. Soft sediment in the Chesapeake Bay is likely mud or peat. See the “Pro tips” below for instructions on how to differentiate between types of soft sediment.
 - b. If penetration is slow and requires more effort, the sediment is sandy.
 - c. If you cannot push your paddle into the sediment, it is hard. Hard bottom sediments in the Chesapeake Bay will likely consist of gravel or rock.
3. Repeat these steps two more times in the monitoring site. The most common type

of sediment (mud, sand, peat, or hard) observed at the monitoring site should be the one recorded.

Pro tips:

- If you press on the bottom, and there is some resistance but the sediment does not feel hard, stir the sediment gently with your paddle. If small chunks of dark material float to the surface, the sediment is most likely peat. If the bottom is soft and your paddle penetrates easily, it is most likely mud.
- You can also use your hand to determine if the sediment is muddy, sandy, peat-based, or hard. Be careful not to cut yourself on shells or other materials that may be hidden in the sediment.

Shoreline type

Overview:

Assess the environment of the nearby shoreline.

Significance:

The type of shoreline nearby can affect the type of bottom sediment, wave energy, water clarity, and amount of nutrients at a site, all of which can in turn influence the presence and growth of SAV. For example, hardened shoreline structures protect shorelines from erosion, yet they can also negatively impact SAV growth by altering wave activity. In this scenario, sediment that would otherwise develop into a habitable substrate for plants to grow gets washed away by tides and currents. The movement of sediments can also cloud the water and cause the water depth to increase, which decreases light availability at the bottom. Many of these issues are avoided at monitoring sites located in calmer environments adjacent to natural shorelines.

Equipment:

None required, binoculars optional.

Method:

1. From the monitoring site, locate the nearest shoreline. Determine whether or not the nearest shoreline is within 100 meters of the monitoring site (about the length of a football field).
2. If the nearest shoreline is more than 100 meters away from the monitoring site, indicate this on the data sheet by writing ">100 m".
3. If the nearest shoreline is within 100 meters, assess the shoreline by panning across, taking note of man-made structures, beach, rock, and vegetation.
4. Record up to three observed shoreline types within 100 meters of the center of the sampling site (sampling circle with a 200 meter diameter) using the list of options on the data sheet, and list them in order from most to least abundant.

Pro tip:

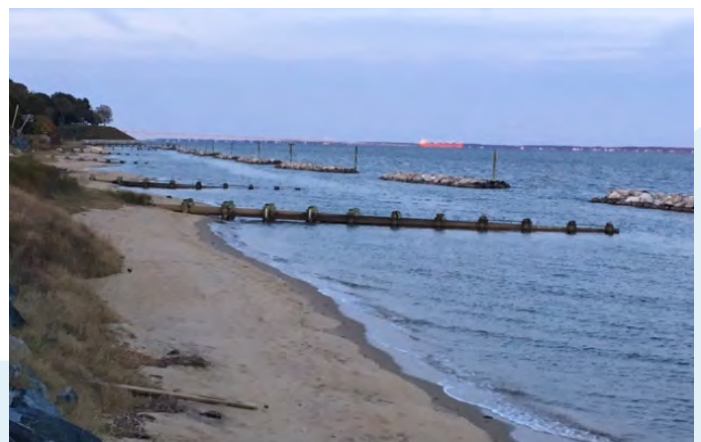
- Review the list of shoreline types (beach, marsh, forest, lawn, bulkhead, on-shore stone, near-shore stone, off-shore stone, soft structure, other) and their pictures in the appendix at the back of this manual before you head out to the field.

Visible shoreline erosion

Overview:

Assess ongoing or recent shoreline erosion.

Significance:

Erosion is a form of habitat degradation where the upper layer of sediment wears away. Not only can erosion have an effect on SAV meadows, but changes in SAV can also cause erosion. The complex canopy of SAV leaves and stems can slow water flow enough to prevent sediment from being washed away and allow suspended sediment particles to sink to the bottom. SAV roots help anchor bottom sediment in place, thus minimizing the risk of sediment erosion. The loss of SAV can mean the loss of bottom sediment stability. Even when SAV is present, sediments can still be washed away if the current moves quickly or forcefully enough. Only coarser sediments remain after an erosion event, and they are less suitable for plant growth and are also a sign of unstable environmental conditions.

Equipment:

None required, camera optional.

Method:

1. Scan the shoreline adjacent to your sample site. Signs of erosion include: exposed tree roots, trees leaning into the water, overhanging or collapsed banks, and steep drops between the shoreline and water surface.
2. Record the presence or absence of erosion within 100 meters of the center of your sampling site (sampling circle with a 200 meter diameter) by checking the appropriate box on the data sheet.
3. If erosion is present, add a description of the erosion in the notes.
4. (Optional) Take a picture of the observed erosion.

Marine debris

Overview:

Record observations of non-organic marine debris or litter present at the monitoring site.

Significance:

An occasional glass bottle or wood plank is not uncommon for near-shore Chesapeake Bay sites. However, excessive marine debris can block light, physically damage plants and animals, and introduce hazardous chemicals into the water. Excessive debris may also indicate a high level of human activity, which can influence the local environment, as a whole, in many other ways.

Equipment:

None required, camera optional

Method:

1. Scan across the monitoring site and look for any pieces of debris underwater, on the bottom sediment, floating on the surface of the water, and on nearby shorelines.
2. Record the presence or absence of debris within 100 meters of the center of the sampling site (sampling circle with a 200 meter diameter) by checking the appropriate box on the data sheet..
3. If debris is present, add notes regarding the type and abundance of debris.
4. (Optional) Take a picture of the observed debris.

Pro tip:

- Pack a trash bag with your monitoring supplies so you can collect any marine debris that you see while monitoring. Properly dispose of the debris once back on land.

Other human impacts

Overview:

Indicate whether or not other human impacts are present at the monitoring site.

Significance:

SAV meadows can be affected by many forms of human impact. For example, dredging and propeller scarring can disrupt bottom sediment and cut through the roots and rhizomes of a continuous SAV meadow. These types of disturbances reduce overall SAV coverage while also fragmenting the remaining plant communities. Sediment disturbances can be an initiation point for erosion when plants are not present to hold bottom sediment intact. Other types of human impacts include sewage overflows, fish kills, oil streaks, and water discoloration due to pollution or erosion. These visible signs indicate that the ecosystem health is impaired, and could also affect the future growth of SAV, as well as the visibility of SAV for monitoring purposes.



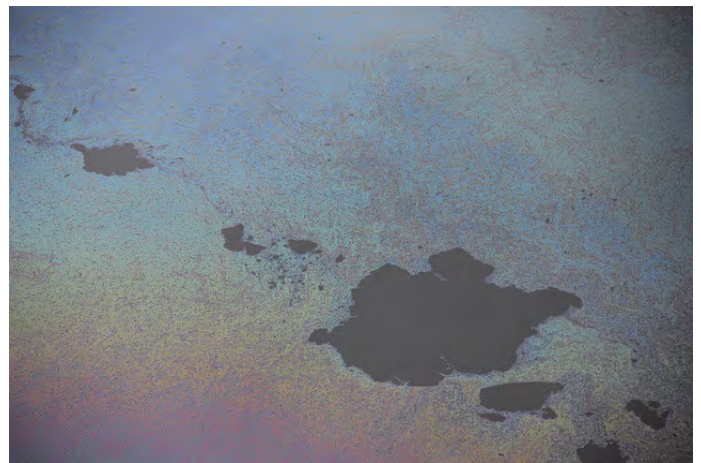

Equipment:

None required, camera optional.

Method:

1. Position yourself in or above the water where the water surface, sediment, and nearby shoreline can be examined.
2. Scan across the monitoring site, looking for any evidence of human impact.
3. Record the presence or absence of human impact within 100 meters of the center of the sampling site (sampling circle with a 200 meter diameter) by checking the appropriate box on the data sheet.
4. If impact is present, add notes regarding the type and severity.
5. (Optional) Take a picture of the observed human impact.

- Recent genetic evidence shows that Ceratophyllales belongs to neither the monocots nor the eudicots; instead, it is a "sister group" to the eudicots
- Most often found in slow-moving waters
- Found in all 50 states
- Sometimes called "Coontail" because it looks like a raccoon's tail!

- Eelgrass beds provide refuge for many species including seahorses, pipefishes, juvenile fishes, blue crabs, and scallops
- May also be referred to as "seagrass"

- Two forms occur in the Bay: one grows upwards, the other grows along the bottom with stems and roots together

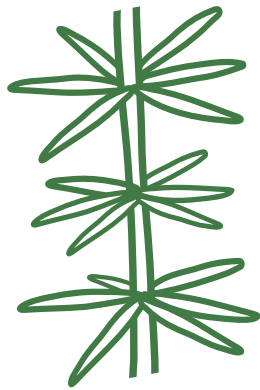
Leaf arrangement terminology

These four diagrams introduce you to terminology that is used throughout the SAV species guide to denote leaf arrangement. *Note: Do not determine leaf arrangement based on where the stem divides, as this will likely reflect an atypical arrangement from the majority of the plant.*

Harmful algal blooms

What are they?

Certain algae species can produce toxins dangerous to humans and aquatic species. When these species reproduce very quickly, or “bloom,” they can form a harmful algal bloom, or “HAB”. HABs may be red, green, or brown in color, and may be made up of rhodophytes (red algae) or chlorophytes (green algae).

Are HABs harmful to SAV?

HABs can block sunlight from reaching SAV species by shading them and reducing water clarity. They can also reduce the amount of oxygen present in water, harming both SAV and the species it supports.

How do I identify HABs?

It is difficult to distinguish a HAB from a non-harmful one, so it is best not to sample in areas with an algal bloom. A HAB may be present if you see floating scum, dots, clumps, stripes, or thick mats on the surface of the water. The water may appear green, blue, red, yellow, or brown.



Warning

Harmful Algal Blooms, or HABs, may produce toxins harmful to human and animal health. If you suspect a HAB, do not sample. Please report suspicious algal blooms to the Chesapeake Bay Safety and Environmental Hotline at (877) 224-7229.

Guide to other macrophytes

Emergent plants

Emergent plants are rooted under water, but have leaves and stems that extend out of or float on top of the water.

Water chestnut (*Trapa natans*)

Where is it found?

Upper Chesapeake Bay tributaries and Potomac

What is it?

Water chestnut is an invasive floating aquatic plant that is actively managed in the Chesapeake Bay. Triangle-shaped leaves form rosettes that float on the surface of the water. The plant itself is bulky but the flowers are small and white.

Is it harmful to SAV?

Water chestnut can block sunlight from reaching SAV, and competes with SAV for space. If you see water chestnut while sampling SAV, alert MD DNR at (410) 260-8634

Lily pads

There are three genera in the Chesapeake Bay: *Nuphar*, *Nymphoides*, and *Nelumbo*

Where is it found?

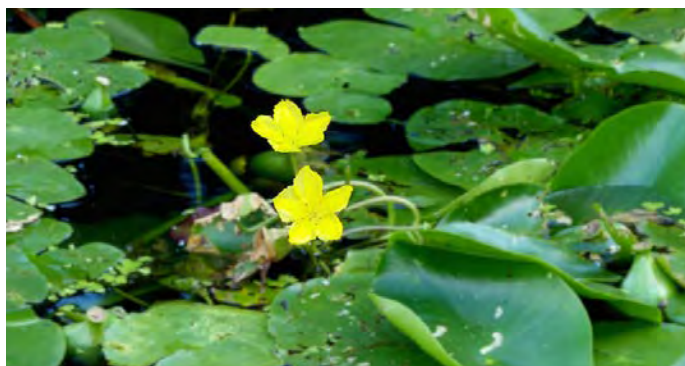
Fresh waters in the Chesapeake Bay watershed

What is it?

Lily pads are native to the Chesapeake Bay. They have large round leaves that float on the water surface.

Is it harmful to SAV?

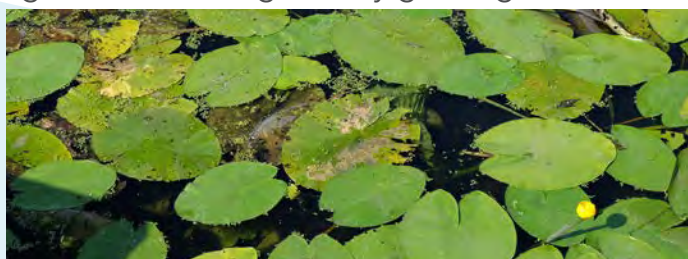
Lily pads, including American lotus, compete with SAV for space and nutrients, and block light from reaching SAV by growing above it.

What species are commonly found in the Bay?

Chara vulgaris (muskgrass)

Nitella flexilis (stonewort)

What is it?

Green freshwater algae can resemble vascular plants and may be mistaken for SAV. These species have what appear to be stems and leaves, with whorls of what appear to be branches. They may attach to the substrate, but do not have roots. *Chara* and *Nitella* may be distinguished from one another based on their branches; those on *Chara* have ridges, while those on *Nitella* are smooth.

Green saltwater algae

What species are commonly found in the Bay?

Ulva lactuca (sea lettuce)

Enteromorpha (turf green seaweed)

What is it?

Green saltwater algae are usually bright green in color. Sea lettuce resembles green sheets of cellophane. Turf green seaweed is similar to sea lettuce, but grows in a tubular morphology. Both may be found attached to the substrate by holdfasts, but are more often observed in mats or clumps rolling around with the tide. Though it is a normal part of the ecosystem, excess nutrients in the water column often lead to blooms of green saltwater algae.

What is it?

Appears red and highly branched, resembling some SAV species. Distinguishable from SAV by color and lack of roots.

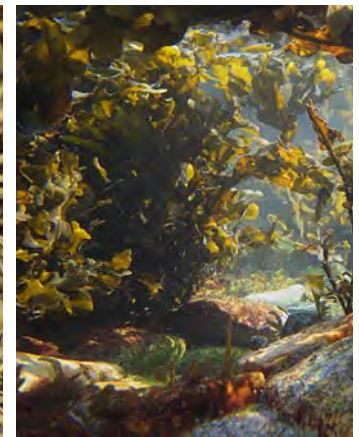

What is it?

Characterized by long, branching fronds with air bladders. *Ascophyllum* fronds have rounded tips.

Lyngbya

What is it?

Lyngbya is a genus of freshwater cyanobacteria that grows in strands that clump together and form mats. During the summer, some species of *Lyngbya* have been found in the northern Chesapeake Bay covering SAV beds and caught in fishing gear. *Lyngbya* occurs naturally, but under certain conditions may “bloom”.

Is *Lyngbya* harmful to SAV?

Lyngbya may overgrow SAV beds, blocking sunlight and inhibiting photosynthesis. *Lyngbya* also competes with SAV for nutrients.

Warning

Lyngbya can be harmful to human and animal health, as associated toxins may cause skin and gastrointestinal inflammation. Avoid direct contact with *Lyngbya* and wash your skin with soap if contact occurs.

Epiphytes

What are they?

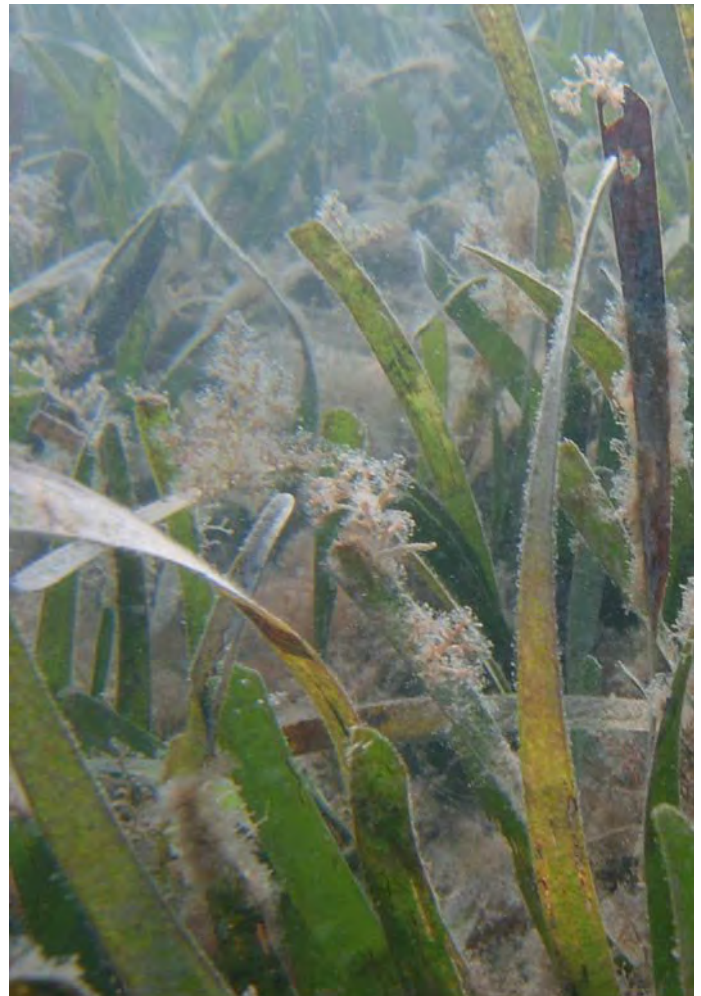
Epiphytes are plants or algae that grow on the surface of other plant species, like SAV.

Are epiphytes harmful to SAV?

Epiphytes are not parasitic, meaning they do not feed on their host plants, and they do not always impact SAV negatively. Epiphytes can become overgrown, however, when nutrient concentrations are too high. When this happens, epiphytes can cover so much of their host SAV plant that they block sunlight from reaching the SAV leaves, inhibiting photosynthesis.

How do I identify epiphytes?

There are many species of epiphytes in the Chesapeake Bay, and they are difficult to distinguish from one another. Look for them on the leaves and stems of SAV. When examining SAV for epiphytes, you may also see epifauna, or small animals that live on SAV.



Animal species

What are they?

Many animal species seek refuge in SAV beds and may cling to SAV stems, roots, or leaves.

Are they harmful to SAV?

While some animal species may consume SAV, they are a natural part of a healthy SAV system.

What species can I find?

You may find snails and barnacles clinging to SAV. You may also find benthic invertebrates, such as isopods or amphipods, larval or juvenile fishes, and commercially important species such as blue crabs. Other invertebrates that use SAV as habitat include clams and scallops. Large predators including adult fishes and sea birds may also be found in and around SAV beds. Other fishes that can be found there are mummichogs, seahorses, and pipefish.

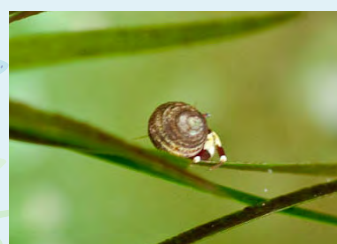

Shoreline types guide

When collecting data on shoreline type, volunteers should first locate the shoreline that is closest to the monitoring site. The nearest shoreline is most impactful to the SAV at that particular location. Volunteers should then record up to three observed shoreline types within 100 meters of the center of the sampling site, listing them in order from most abundant to least abundant.

Only coastal land that is directly adjacent to the water should be recorded as shoreline. For example, if a bulkhead at the edge of the water has partitioned a forest from direct contact with a tributary, then the shoreline should be classified as a bulkhead because the bulkhead stands between the forest and the water. Similarly, if a near-shore stone structure is positioned parallel to a marsh landscape, the shoreline should be classified as near-shore stone because that structure is closest to the SAV bed. If, in these two cases, there are portions of the natural forested shoreline that are not reinforced with a bulkhead, or portions of the marsh shoreline that are not protected by near-shore stone structures, both types of shorelines should be recorded. If there are multiple shoreline types present at a monitoring site, mentally calculate which percentage of the total shoreline can be classified as each type, and record the shoreline types in order from highest estimated percentage to lowest.

Finally, many of these shorelines can be tricky to distinguish depending on the tide. For example, small “beach” areas can appear along shorelines at low tide. In cases like these, shorelines should not be classified as beaches because in order for a shoreline to qualify as a beach, there must be a substantial stretch of sand exposed at high tide. Similarly, a stone structure positioned at the edge of a marshy area could appear at first to be an on-shore

stone structure when observed at low tide, but if the structure is inundated at high tide and allows tidal flow between the flooded marsh landscape and the body of water, it should be classified as a near-shore stone structure. Differentiating between shoreline types based on their appearances and functions at different tide levels is critical as a volunteer monitor.

Participants in the *Chesapeake Bay SAV Watchers* Monitoring Program will collect data on nine types of shorelines. If another type of shoreline is observed, monitors should record the shoreline type as “other”. In these cases, volunteers are encouraged to take a picture of the unusual shoreline type and note any additional observations on their data sheet. If the monitoring site is located more than 100 meters away from the nearest shoreline, such as in the Susquehanna Flats, observers should record the shoreline type as “> 100 m”. The nine major shoreline types are listed and described in the following pages.

Beach

A beach shoreline consists of a sandy slope. Beaches are sometimes vegetated and often border a variety of habitats such as forest, marsh, and lawns. If a substantial distance of sandy beach remains exposed at high tide, the shoreline should be categorized as a beach. Sandy shores completely submerged at high tide do not qualify as beaches.

Marsh

Marsh habitats are specially adapted to daily flooding that stems from the ebb and flow of the tide. In the Chesapeake Bay, marshes are mainly characterized by dense mud, peat, and grassy vegetation. In fresher areas, the vegetation consists of grasses such as wild rice (*Zizania aquatica*), and broad-leafed emergent species like arrow arum (*Peltandra virginica*) and pickerelweed (*Pontederia cordata*). In brackish and saltier waters, cattails (*Typha sp.*) and *Spartina* grasses are common. Invasive *Phragmites* reeds are also present in marshes throughout the Chesapeake Bay. Many shoreline modification techniques incorporate marsh habitat in their designs, but only a natural marsh without man-made structures should be classified as a 'marsh' when monitoring.

Forest

A forest shoreline is vegetated by shrubs and trees as opposed to grasses. Forested shorelines may be in the process of transitioning to marsh or beach. If the majority of trees are still living and appear to be the dominant species over marsh grasses, then the shoreline should be categorized as forested. If very little beach remains exposed at an average high tide, the shoreline should be categorized as forested.

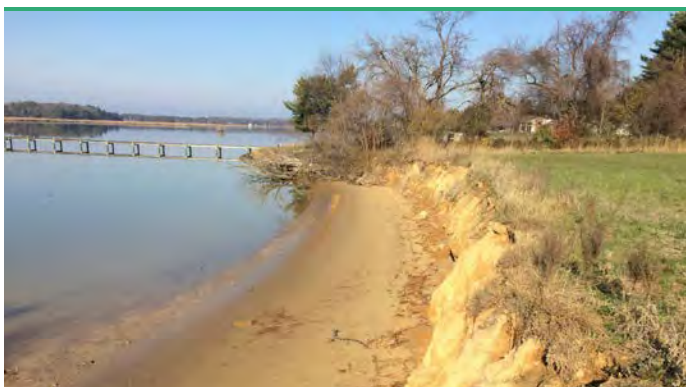

Lawn

A lawn shoreline consists of any manicured, human-maintained landscape, turf grass lawns being one of the most common features. An area containing decorative gardening would also be considered a lawn. A shoreline should only be classified as a lawn if the grass is bordering the water's edge - not when other shoreline structures, such as marsh grasses or on-shore stones, are located between the water and the lawn. In some cases, lawn shorelines may have a small amount of natural vegetation or sandy beach at their edge. The key characteristic of a lawn as it impacts SAV habitat is that it does not retain water or excess nutrients from stormwater runoff.

Bulkhead

A bulkhead is a vertical wall built at the edge of a shoreline. Bulkheads are often made from timber, metal, or vinyl. Sometimes, sediment accumulates at the base of the bulkhead, and a small beach or marsh area develops in front of a bulkhead. If waves cover the beach or marsh and hit the bulkhead regularly, the shoreline should be classified as a bulkhead. Bulkheads are also sometimes paired with other shoreline structures such as groins or breakwaters. The shoreline should be categorized as a bulkhead if waves crash directly against the bulkhead.

On-shore stone

On-shore stone structures run parallel to the shoreline. Most often, on-shore stone consists of stone revetment or riprap. There is often some vegetation on the landward side of the structure and sediment build-up in the water at the base of the structure. Groins or headland spur breakwaters - stone structures that run perpendicular to the shoreline and leave the shores mostly exposed to the water - should not be in this category. On-shore stone shorelines can be distinguished from near-shore and off-shore stone shorelines in that on-shore stone is positioned directly at the water's edge at high tide, and some stones remain exposed even when the water is at its highest point.

Near-shore stone

Near-shore stone structures run parallel to the shoreline and are usually placed about 10 meters out towards the water from the high tide line. A stone sill is the most common type of near-shore stone structure. Near-shore stone structures allow tidal flow and wildlife to transition between the open water and protected areas near the shoreline. Near-shore stone structures regularly have water on both sides of the rocks, whereas water remains only on one side of on-shore structures. Furthermore, unlike off-shore stone structures, near-shore stone structures are also easily accessible from land.

Off-shore stone

Off-shore stone shorelines will most often consist of breakwater structures that are located further away from shore - about 15 to 30 meters out towards the water from the high tide line. Off-shore stone structures protect beaches and other shorelines by reducing wave action and erosion. Unlike near-shore stone structures, off-shore stone structures are not easily accessible from the shoreline. Breakwater structures are also much larger and taller than near-shore structures. At times, a shallow or exposed sand bar will form, connecting the breakwater structure to the land and forming 'pocket beaches' as a result.

Soft structure

Soft structures most often consist of coir sills that use natural coconut fiber 'coir logs' in place of stone structures. These structures are used in shoreline restoration projects to stabilize sediment along a shoreline in order for plants to eventually establish themselves and develop a root mat. The coir logs naturally break down over a few years as the plant population grows more stable.

Multiple shorelines in a row

Sometimes volunteers may find that there are multiple shoreline types positioned along the nearest shoreline. In these cases, volunteers should record up to three types of shorelines that are most prominent, listing them in order from most to least coverage.

Other

Other shoreline types include groin and spur structures that run perpendicular to the shoreline. Groins are sand containment structures that are composed of large stones or timber. Breakwater spur structures create a crescent shaped beach or 'crab claw' shoreline. To restore shorelines, sometimes marsh or beach grasses are planted behind the structures. Another alternate shoreline type is a constructed cobble beach, which uses strategically placed small stones paired with marsh planting to stabilize a shoreline. In some areas, shorelines are stabilized using oyster reefs or castles, which are positioned parallel to the shore. Finally, there are many unique shoreline configurations that cannot be described by the specified categories.

Printing instructions

Chesapeake Bay SAV Watchers Monitoring Program participants can view and download all of the program materials from the program website at www.chesapeakebaysavwatchers.com. The following section contains printing instructions for several program materials.

Methods Manual

Print double-sided and select the "Flip pages on long edge" option on the Print menu. Print on standard printer paper and store pages in a 3-ring binder.

Introductory Monitoring Program Guide

Print double-sided and select the "Flip pages on long edge" option on the Print menu. Print on standard printer paper and staple the pages together.

Certificate

Select "Fit" on the print menu to print the certificate. We recommend that you print the certificate on cardstock and use a dark pen or thin-tipped marker to fill out the information.

Data sheet

Print double-sided on Rite in the Rain paper, which can be purchased online at <https://www.riteintherain.com/copier-paper-500-white-20-bond-8-1-2-x-11>. When printing on *Rite in the Rain* paper, use a copier or laser printer. Do not use an ink-jet printer. Be sure to use a pencil to record your observations in the field.

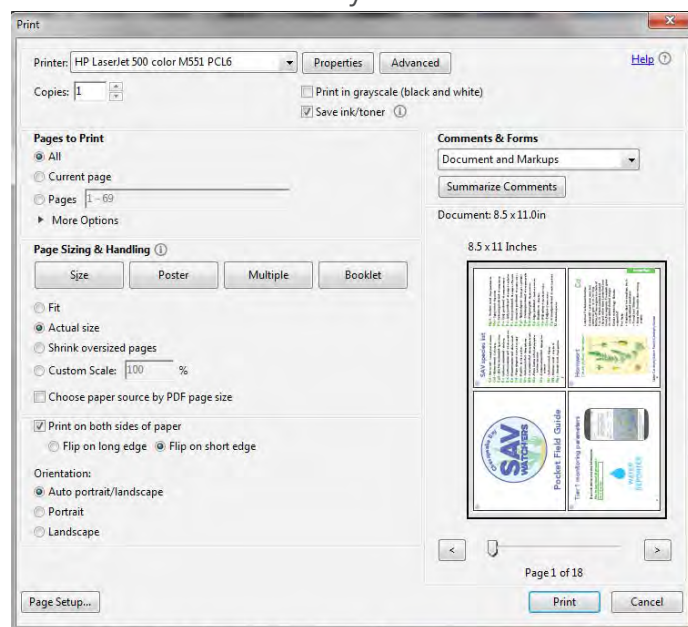
Pocket Field Guide

Volunteers can choose what type of paper to use when printing the Pocket Field Guide. The first recommended option is to print on *Rite in the Rain* 8.5 x 11" cardstock paper, which can be purchased online at <https://www.riteintherain.com/card-stock#HW8511>. When printing on *Rite in the Rain* paper, use a copier or laser printer. Do not use an ink-jet printer. Print double-sided and select the "Actual size" and "Flip on short edge" options on the Print menu to ensure that the

cards print in the correct orientation. Once printed, cut the pages to size and hole punch each card using the provided circle guide. Use packing tape to cover the Site ID and image description boxes on the last card. This layer of plastic will allow you to write on this page with a dry erase marker while monitoring.

The second recommended option for printing the Pocket Field Guide is to print on standard 8.5 x 11" cardstock paper. Print double-sided and select the "Actual size" and "Flip on short edge" options on the Print menu to ensure that the cards print in the correct orientation. Once printed, cut the pages to size and then work with a printing company to laminate each card individually. After the cards are laminated, hole punch each card using the provided circle guide.

Store all the cards on a medium-sized book ring, which you can purchase from Amazon by searching for "medium-sized book ring". We recommend also attaching a carabiner onto the ring so that your Pocket Field Guide can easily be clipped and unclipped to your life jacket or another location for easy access.



The Pocket Field Guide will print four cards on one page. The cards will be approximately 4 x 5 inches, or about the size of a large index card. (Suzi Spitzer)

How to digitize and share Tier 2 data

Labeling and organizing photographs

High-quality photographs are essential components of SAV monitoring data. Photos serve as a means of data quality assurance, and allow experts to use volunteer-collected data in a greater variety of contexts, including in scientific reports that inform policy and management decisions. It is extremely important that all pictures are labeled in a way that clearly links them to the rest of the monitoring data collected during the same sampling event.

To label your photos, follow the steps below.

1. Download all images onto a laptop or desktop computer and save the images in a folder.
2. Open the folder and select an image file to open. View the Site ID and image description pictured and make a note of this information.
3. Close the image and return to the folder.
4. Right-click on the file and select "Rename".
5. Rename each of the pictures individually using the specified *Chesapeake Bay SAV Watchers* naming convention which is the Site ID plus a one or two word image description.
 - a. Example: The image file name "180628.1358.SS_lyngbya" describes a photo of *Lyngbya* taken at site 180628.1358.SS, while the image file name "180628.1358.SS_HdFlower" describes a photo of flowering water stargrass (*Heteranthera dubia*) taken at the same site.
6. Special cases:
 - a. If there are multiple photos describing the same type of observation at a sampling

site, add a number after the image description to differentiate the pictures. For example, "180628.1358.SS_lyngbya" and "180628.1358.SS_lyngbya2" describe two different photos of *Lyngbya* taken during the same sampling event.

- b. If there are multiple SAV species present in the same image, include both species abbreviations in the file name. The file name "180628.1358.SS_Hd+Va" would indicate that water stargrass and wild celery are both pictured.
7. After renaming an image file, double-check that the Site ID pictured matches the Site ID in the file name.
 - a. The Site ID should always be included in the photo itself, as an extra means of ensuring the images are linked to their associated monitoring data.

The *Chesapeake Bay SAV Watchers* Monitoring Program requires that volunteers submit photos to accompany data on observed SAV species, SAV flowers and seeds, and other macrophytes, including *Lyngbya*, macroalgae, and emergent plants. Therefore, each monitoring site should have at least one associated photo, except in cases where no SAV or other macrophytes are observed at the site. When labeling images, double-check your data sheet and ensure that you have photographic data for each observed species of SAV and for any SAV flowers and seeds or other macrophytes that were present at the monitoring site. It is strongly recommended that volunteers or monitoring group coordinators label all photos from a monitoring event soon after the monitoring takes place, in order to minimize the risk of mislabeling or misplacing image files. Store all re-named images in a single folder.

To sort the images according to monitoring event, follow the steps below.

1. Open the folder containing the images
2. Right-click the white space around the image files

3. Select "Sort by"

4. Select "Name".

It is recommended that photos are backed up to a second location, using an external hard drive, a thumb drive, or a cloud-based storage option such as Dropbox or Google Drive. Volunteers should contact their certified monitoring group coordinator or Riverkeeper to determine the best way to share their labeled photos and paper data sheets.

Digitizing data sheets

Volunteer monitors should give all paper data sheets to their certified monitoring group coordinator or Riverkeeper so that written data can be transferred to a standardized spreadsheet. This digitized data can then be shared with Chesapeake Bay scientists and managers. Certified monitoring group coordinators and Riverkeepers should download the data digitization Excel template from the *Chesapeake Bay SAV Watchers* webpage. You must have Microsoft Office Excel in order to do this. Rename the Excel template to include the name of the monitoring group, and save the file in a safe place.

The data digitization template has multiple sheets, or tabs, which serve specific functions. To digitize data from a printed data sheet, volunteer coordinators should open the Excel template and navigate to the first tab, labeled "data sheet- FILL OUT SHEET," at the bottom of the window. In order to streamline the process of data digitization, this spreadsheet page is designed to resemble the printed *Chesapeake Bay SAV Watchers* data sheet. This template can be used to digitize the information written on one full printed data sheet containing three sampling sites at a time. Each sampling site is designated by a color in column A of the data sheet.

To digitize your data, follow the steps below.

1. Basic information: Fill in the basic information in rows 1 and 2. This information is the same for all three sampling sites. It includes the observer and group names, the sampling date, a general description of the sampling area, and the high and low tide times.
2. Next, begin filling out the rest of the Excel sheet one sampling site at a time, starting on the left side of the data sheet and working your way across. This information will be the same for all three sites on the data sheet.
3. Site ID and Coordinates: Carefully copy the Site ID and GPS coordinates. Make sure to double-check that these numbers are transferred correctly!
4. Time: Copy the sampling time using a 24-hour format.
5. Depths: Transfer the Secchi and water depths. These measurements should have been taken in centimeters.
6. Sediment: Use the drop-down menu within the cell to select bottom sediment type.
7. Shoreline: Use the drop-down menu within the cell to record up to three shoreline types. Transfer any handwritten notes about shoreline type into the shoreline comment box.
8. SAV Species: Copy the handwritten ordered list of up to eight SAV species observed at the sampling site.
9. Flowers and Seeds: For each species, indicate whether flowers and seeds were present or absent using the drop-down menu within the cells in column I.
10. Photos: Each species should be included in a photograph from the sampling site. In each row, include the name of the image containing that particular SAV species. If multiple images are provided for one species at the same sampling site, include all image file names in the cell, separated

by commas (e.g. 180628.1358.SS_Hd, 180628.1358.SS_Hd2). If multiple SAV species are pictured in one image, copy the file name in the image file name column next to each species that is pictured. If a species is listed but does not have an accompanying image, type "no image" in the row next to that species. Remind the volunteer identified at the top of the data sheet that a photo must be taken for each observed species.

11. Other Data: Use the drop-down menu within the cells in column L to indicate the presence or absence of SAV at the surface, epiphytes, shoreline erosion, and human impact. These four parameters do not require a photo; however, if an image is provided, include the image file name in the Notes box in column O. Also include any notes on these parameters in the Notes box in column O.

12. Emergent plants: Indicate the presence or absence of water chestnuts and lily pads. An image is required when either of these two parameters are observed. Include the image file name in column M.

13. Density Data: Use the drop-down menu within the cells in column O to indicate the density of Total SAV, *Lyngbya*, and macroalgae. An image is required when *Lyngbya* or macroalgae are observed. Include the image file name in column Q.

14. Macroalgae: Use the drop-down menu to indicate up to three types of macroalgae observed at a sampling site.

15. Notes: Include any extra handwritten notes in the Notes box in column O.

16. Repeat these steps to transfer all data from the three sampling sites on a printed data sheet.

17. Tab 2: Once all of the information from a single data sheet (three sites) is transferred onto the first tab of the Excel template, navigate to the second tab labeled "2. excel converter- DO NOT TYPE". This second sheet automatically translates all of the information on tab 1 into a standard Excel format. Data on the second tab can only be modified by making changes to the corresponding fields on the first tab. All data from one sampling site populates a single row of the data table. You should see three rows of data that correspond to the three sampling sites on the first tab of the template.

18. Copy Tab 2 Data: Select the three rows of data. Do this by first hovering your cursor over the row numbers on the far left of the Excel window, and then clicking and dragging to highlight rows 2 through 4. Copy the rows by selecting Home > Copy from the menu at the top of the window, or by pressing and holding Control (Windows)

or Command (Mac) on the keyboard and then pressing the “C” on the keyboard, or by right-clicking and selecting Copy from the pop-up window.

19. Paste to Tab 3: Navigate to the third tab of the Excel template, labeled “3. PASTE FINAL DATA here”. This tab is where you will store all of your data for the entire monitoring season. Scroll down the page to the first empty row and highlight the row by selecting the row number on the left border of the window. Paste the three copied rows of data that you just entered by selecting Home > Paste from the menu at the top of the window. Make sure to select “Paste Values” (icon with clipboard and numbers 1 2 3) from the Paste menu in order to correctly transfer your data by removing all links to other tabs. You can also paste the data by pressing and holding Control (Windows) or Command (Mac) on the keyboard and then pressing the “P” on the keyboard. Again, make sure to select “Paste Values” by right-clicking the highlighted pasted data and selecting the correct option from the Paste menu. Double-check that your data pasted correctly by selecting a pasted cell and confirming that links to other sheets are not present in the Formula Bar. The text in the selected cell should match the text in the Formula Bar.

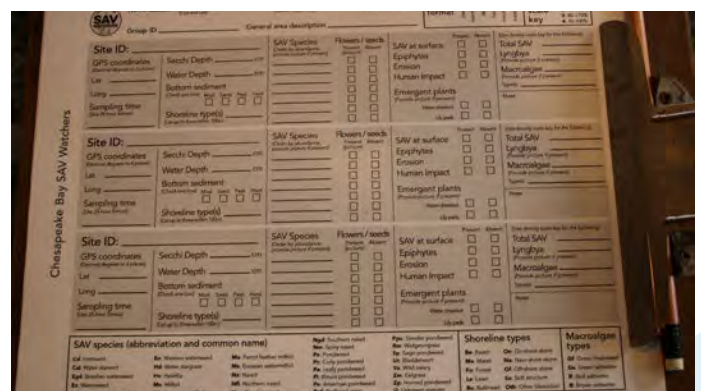
20. Save: Remember to “Save” your progress regularly to avoid losing data.

21. Prepare to enter more data: Once your data is pasted in the third tab, it can be deleted from the first tab. Always clear all data from the first tab before beginning the process of entering new data from another data sheet. There is no need to worry about accidentally deleting important text or removing formatting from the Excel template because all cells that do not store data from the printed data sheets are locked. Deleting data from the first tab will automatically delete the data on tab 2. Do not delete data from the third tab!

22. Enter More Data: Repeat these steps for each data sheet. The third tab of the Excel template should accumulate more rows of data as data sheets are digitized over the course of a monitoring season.

23. Keep Copies: Always keep paper data sheets or scanned copies of paper data sheets as back-up, just in case they are ever needed.

24. Store in Multiple Locations: Finally, it is recommended that volunteer monitoring coordinators save their populated excel files to the cloud (e.g. Dropbox or a Google Drive folder) throughout the monitoring season. Save your data file using the updated date of entry each time you enter more data (for example, if you enter SAV data on July 1st, 2019, your file name should be ‘Monitoring Group_SAV data_7.1.2019’. Then, when you update that file with more data on September 1st, for example, use the “Save as” option rather than just saving it so a second file is created and name it ‘Monitoring Group_SAV data_9.1.2019’). By doing so, you preserve previous versions of the file in case of accidental data deletion, while also backing up your data.

Submitting data

All photos and Excel data sheets should be shared with the Chesapeake Bay SAV Watchers Monitoring Program Coordinator at the end of the sampling season by uploading files to the Chesapeake Bay SAV Watchers shared Google Drive. Please email Brooke Landry at brooke.landry@maryland.gov to request access to the Google Drive.

Once access is granted, you can start uploading your files and photo folders to the main folder, or if there is a sub-folder within the Drive for your group, upload your data to that folder specifically.

Each monitoring group should submit one Excel data sheet containing all of the digitized data from the printed data sheets for that season as well as one folder containing all labeled photos from that season.

How to retrieve a GPS location using a smartphone

Google maps

Retrieve coordinates of current location

1. Press the circle icon with the triangle in it in the bottom right corner to center on your current location.
2. Zoom in to your current location (blue dot with white circle edge) until you cannot zoom in any further.
3. Press and hold your finger on the screen directly on top of your blue locator dot until a red bubble pin appears and the words "Dropped Pin" appear in the location search bar.
4. Press the white "Dropped Pin" menu at the bottom of the screen and scroll down until the GPS coordinates appear.
5. Write down the coordinates very carefully and double-check each number.

Add a location as a recurring site

1. Press the "Add Label" button (flag icon) in the "Dropped Pin" menu.
2. Type in a site name that will help differentiate this location from others you might save.
3. Press "Done" in the top right corner.
4. Press the "Save" button (bookmark icon) in the "Dropped Pin" menu.
5. Press the "Favorites" (heart icon) button or specialized SAV locations list (must create this- see below).

Create a specialized list

1. Press the "Save" button (bookmark icon) in the "Dropped Pin" menu (above).
2. Press "New list" (plus icon) at the bottom of the menu.
3. Type in a list name (e.g. My SAV sites, SAV monitoring locations, etc.).
4. Press "Create". Your existing pin will automatically be saved into the new SAV list.
5. Double-check that the pin was added to the list. On the "Dropped Pin" menu, under the section "Saved in your lists," your SAV list name should appear next to a blue list icon.

Navigate to a recurring site (that was previously marked)

1. Press the menu icon (three horizontal lines) at the top left of the screen.
2. Press "Your places".
3. Scroll in the "Label" menu until you find your labeled location OR use the "Saved" menu to access your "Favorites" list or a specialized SAV list (if you created one).
4. Press your labeled location on the menu.
5. Press the blue "Directions" button in the bottom right corner.
6. Press the blue "Start" button and follow the app's directions until the white box at the bottom of the screen says "You made it to (location name)".
7. Press the red "Exit" button at the bottom of the screen.
8. Exit the "Dropped Pin" location menu by swiping it towards the bottom of the screen.
9. Zoom in to your current location (blue dot with white circle edge) until you cannot zoom in any further.
10. Adjust your location until your blue dot is as centered as possible on top of your red marked location bubble.

Apple maps

Retrieve coordinates of current location

1. Press the arrow icon in the top right corner to center on your current location.
2. Press the information icon (i in a circle) in the top right corner to open the "Maps Settings" menu.
3. Press "Mark my location" to open the "Marked Location" menu and scroll down until the GPS coordinates appear.
4. Write down the coordinates very carefully and double-check each number.

Add this location as a recurring site

1. Press the "Favorite" (heart icon) button in the Marked Location menu (see above).
2. Type in a site name that will help differentiate this location from others you might save.
3. Press "Save".

Navigate to a recurring site (that was previously marked)

1. Press the navigation box at the bottom of the screen to search for a place or address.
2. Scroll to the bottom of the box until you see the "Favorites" section.
3. Press the "Favorites" section and scroll in this menu to your desired site.
4. Press the site name and then press the large blue "Directions" box.
5. Press the green "Go" button and follow the app's directions until the black box at the top of the screen says "Arrived".
6. Press the big red "End Route" button at the bottom of the screen.
7. Exit the "Marked Location" menu by pressing the small gray "x" icon at the top right of the menu box.

8. Zoom in to your current location (blue dot with white circle edge) until you cannot zoom in any further.
9. Adjust your location until your blue dot is as centered as possible on top of your red marked location bubble.

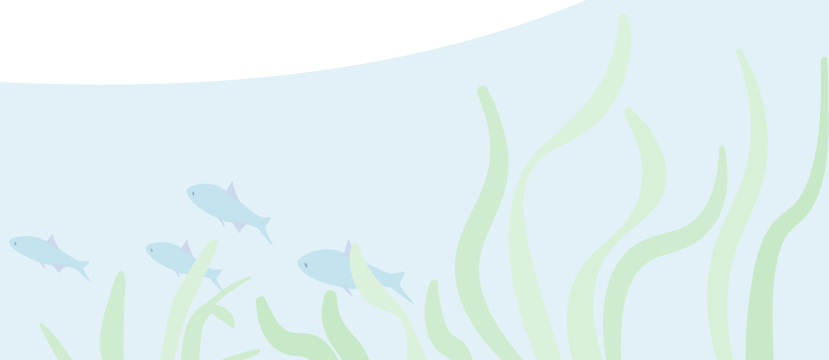
